Friday, October 26, 2018

The second day of the 145th Annual Session was opened in the fourth degree at 8:30 am by the officers of the NH State Grange.

Roll call of Granges found a quorum present.

State Master Chris Heath recognized Phil Prelli, Overseer of the National Grange and his Maureen, and Leroy Watson, member of the National Grange Executive Committee.

The minutes of Thursday evenings session were read and approved.

The Master's Address committee was announced: Richard Patten, Chairman, Camilie Twiss and Doris Mitton

Two new resolutions were presented and read

Resolution #6 Submitted by: Claremont Grange #9 Subject: Humane Treatment of Animals

Whereas the NH State Grange cares about the welfare of all animals in our state; and

Whereas there has been a noted increase in animal hoarding and cruelty cases in our state;

Therefore, be it resolved that the NH State Grange supports laws to address the mental health disorders relating to animal hoarding and cruelty.

Resolution #7 Submitted by: Claremont Grange #9 Subject: Livestock, Pet and Animal Seizure

Whereas the NH State Grange cares about the welfare of all animals in our state, especially Livestock and our beloved pets; and

Whereas the NH State Grange believes that all pet and livestock owners must be afforded due process of law; and

Whereas the NH State Grange believes that property rights must be protected according to law; and

Whereas the NH State Grange believes that seizure of animals should only be enforced as a last resort, and then only with advice of the State Veterinarian or a NH Licensed Veterinarian.

Therefore, be it resolved that the State Veterinarian or his/her designee be the sole decisionmaker in the seizure of livestock; and

Be it further resolved that local law enforcement officers be the decision-makers regarding seizure of small animals or pets, only with the advice of a licensed and practicing veterinarian; and

Be it further resolved that local law enforcement officers and/or licensed veterinarians are the only authorized investigators in cases of animal abuse and neglect; and

Be it further resolved that local law enforcement officers be required to use the manual for police officers published by the Governor's Commission on the Humane Treatment of Animals as their guide to identifying and dealing with animal cruelty; and

Be it further resolved that NH judges should always have discretion in the sentencing of citizens convicted of animal neglect, and that judges should take into consideration various options for animal seizure, including seizure in place; and

Be it further resolved that the cost of care for any seized animals must be reasonable and free of administrative costs.

2018 Convention Rules were read and approved

Standing Rules of the 145th Annual Session New Hampshire State Grange of the Order of Patrons of Husbandry

The Best Western Sovereign Hotel Keene, New Hampshire October 25 – 28, 2018

- 1. All persons, except special guests, must be registered. Nametags and programs will be issued at the Credentials table.
- 2. Admission to the meetings shall by nametag and 4th degree password only. Upon giving the password, the meeting Deputy will provide a colored sticker for your badge indicating that you are a member in good standing and will not need to give the password again. If you are not wearing your nametag you will be refused admittance. The 4th and 6th degree passwords will need to be given for admission to the opening of Session on Thursday and to the Conferral of the 6th Degree.

- 3. As a common courtesy to all members, cell phones are to be turned off, or set on vibrate. If your phone makes a sound during the meeting you will be expected to pay a fine of **\$5.00** to the State Gatekeeper.
- 4. At least fifteen delegates shall constitute a quorum of the State Grange.
- 5. Every Subordinate and Pomona Grange in good standing shall be represented by the Master or his/her alternate and one other delegate from said Grange.
- 6. The voting body of the State Grange shall be all registered delegates.
- 7. Members attending as non-delegates may take part in discussion, with permission from the chair, but shall not make motions and shall not vote.
- 8. A member wishing to speak shall wait for recognition by the Master, and upon provision of a working microphone shall announce his/her name and Grange he/she is representing.
- 9. When two members rise to speak at the same time, the chair will first recognize the member standing the furthest distance from the Master's station.
- 10. No delegate shall speak more than two minutes on any question under discussion nor may speak a second time until all others who wish to speak have had the opportunity to do so.
- 11. All reports and other materials for the permanent record, immediately on presentation, shall be given to the State Secretary, via a Scandisk which the State Secretary has provided and a paper copy or any report.
- 12. The rules contained in the current edition of <u>Robert's Rules of Order Newly Revised</u> shall govern the meeting in all cases where they are applicable and in which they are not inconsistent with the By-laws and the Standing Rules.
- 13. These Standing Rules shall be presented to the members for adoption; a 2/3 vote shall be required for adoption.

2018 Session Coordinator report

The last time we were here at the Best Western ~ Keene was when Past Master Janes Tetreault was elected. Doing the math makes that 8 years ago. A lot has changed since then. The hotel has remolded and the front lobby has a new look as the stone wall and staircase going to the second floor is gone. The room that use to house the display area is now an open seating and social area. The city of Keene has done road construction and now have a rotary/traffic circle that will prove to be very interesting to those not familiar with the area.

Before I report to you about the setting up of this session I want to take a few minutes to share with you some of the changes that were made as a result of the Session Evaluations that you are asked to complete each year.

This year the opening time for Friday's session was moved up to 8:30 am, and the song sheets in the packets include the sheet music.

Overall, attendees are happy with the exception of the cost, of the rooms and meals, want more frequent break times, too cold in the meeting room, banquet is more for non-members then for Grange members (price), why do we have the Foundation meeting? I would like to answer some of these.

As for the cost of the rooms' we try and get the best rates possible for the rooms but this time of year it is still considered peak foliage season so rates are still high. Food costs, the last several

years we have been at facilities who have outside caterers do all meals and we have to use those caters. Temperature in the meeting room, this is difficult to find a solution for. The room that we are in are designed to heat and cool based off of the number of people in the room. However when you have a space designed to hold 300 people and you only have 100 in that space it is difficult to heat. If it is possible to get people closer and use less space this would be easier to control.

If it is possible during this session to have a productive discussion as to what you would like to see added or changed, I would welcome that. If not please add your suggestions to the evaluation form.

Now on with this year's session!

I want all of you to look around and see what this room looks like and imagine it empty. Well that is exactly how the room looked yesterday morning that is until the Stewards and Graces along with their band of doers descended upon The Best Western. Devoted and dedicated as they are, they worked tirelessly to prepare the meeting space for last evening's opening and will continue to take down and re-set throughout the weekend.

I want you to also keep in mind that the display space, as limited as it is was completely empty yesterday as well until the Directors arrived with bags and boxes, and bins containing all the handiwork of our talented members. Please make sure you visit the display room and spend some time looking at each department, and maybe spend a little money there as well. Getting to this point has not been an easy task!

I began contacting the Best Western in the summer of 2017 and asked to have The Grange penciled in for the 2018 session. At that time, I was instructed to contact the Representative in December and we would schedule a date for a meet and greet and to discuss what our needs.

December came and several calls were made and no response from the messages left. Out of frustration, I called the Hotel again and this time requested to speak to the General Manager, only to have to leave a message. Shortly after, I receive a call informing me that a new Sales Manager is on board and happy to work with our group. We met and all arrangements were set. So, I thought!

It is customary to have a walkthrough of the facility for the Stewards and Flora to see the space once the contract is signed and the deposit is made. Several attempts were made to arrange this and a date was finally agreed upon in August only to be told the day before that the date would not work for the hotel rep. Several calls were made and again no response.

I was now getting very annoyed and decided to see if we could move to another location for the session. I contacted the Holiday Inn in Concord they were available for the dates we needed with the exception of Thursday.

Meanwhile, State Ceres Kerriann was having the same difficulties trying to contact someone to set up the banquet. She personally contacted the approved caterer and set up a menu but needed

to get pricing from the hotel rep only to finally get a response back stating that what she selecting can't be served at the hotel. Several more e-mails back and forth and finally a menu and price were set. It's now September and this information needed to be out several ago. I would like to take a minute and thank Kerriann for all her efforts in putting the banquet together. It will all be over in a few hours!!

At one point, I received a call from a member saying that they called to make reservations only to be told that the block of rooms has been sold out. I called and got the run around only to find out that the block was not set. This happened two more times.

On October 9th I received an e-mail from the boss of the Representative that we have been dealing with stating that the young lady is no longer employed with the Best Western and that she will be taking over the event.

I met with Laura at the hotel the next day only to find out that most of what we had requested and things needed were never set up. The block of rooms was never set, small groups that normally use some of the meeting space we need were not moved to other locations, and our deposit was never charge to the credit card. The list goes on. Four hours later, all arrangements were completed and set. Only one thing needs to be rearranged and that is the hospitality space which ends up benefitting our group. If anyone staying here at the Best Western was told that the block was sold out and you could not get the Grange rate let me know and we will get that corrected.

As I close this report, please keep in mind that regardless of the actions of the prior representative, the NH State Grange is being taken care by the staff of the Best Western and working diligently to meet all our needs.

State Session should be a time to celebrate the past year and get fired up for the new one. That is why I'm asking for your help by completing the survey

In conclusion, I would like to thank all who helped in preparing for the session. The delegates for attending and participating in the deliberations that are set before us and to the non-delegates for your attendance and interest in what the Sate Grange is doing. I look forward to see you all next year when we meet again in our State Capitol at the Holiday Inn ~ Concord!

2018 Legislative Report

Worthy Master, National Representatives, Fellow officers, Delegates and Grangers all, I come before you today for my 8th annual report as your Legislative Director. This may or may not be my last in that role.

During the last eight years we held six 'Grange Days at the State House'. We additionally had a 'Grange day at State Government', when we toured the Fish and Game headquarters, the best building in our State Government, and were treated to an unusual tour of the NH Supreme Court.

One of the highlights of my tenure was the 2016 National Grange Legislative Fly – In, that we hosted here in New Hampshire in conjunction with the NH First in the Nation Presidential Primary. National Grange Legislative Director, Burton Eller, Jim Tetreault, Tara Sad and I worked for months to put the program together. We had 30 plus attendees from as far away as California. All the feedback we had was positive. We were asked to do it again in four years. I have also attended two Fly-Ins in Washington, DC, but none recently. Timing was always an issue with the legislature and still is with my role with the Council of State Governments.

On the Resolution Front, we passed a resolution that will allow the Executive Committee to pass a policy, provided that it goes to the delegate body at the next annual session. That allows the Grange to take a position on legislation and lobby for or against it, while it is still before the legislature. Your Legislative Department has every year told the Grange that we would help work or format resolutions. There have been few takers, but some over the years, including one in your packet today. We have lobbied several bills, for or against, on behalf of the NH State Grange. We have also sent letters on behalf of the NH State Grange on federal issues, when it fit our policies.

One of my goals as Legislative and previously Agriculture Director, was to bond a closer relationship to the Farm Bureau. For the last six years I have represented the Grange on the Farm Bureau's Government Affairs Committee. As a side note, I am a member of the Farm Bureau too. I am a Director of the Hillsborough County Farm Bureau and participate on the State Farm Bureau's Dairy and Policy Committees.

I will close with reminding the delegates that the Legislative Department presents an Outstanding Legislator Award each year. Over the past 7 years we have given seven awards to some very deserving legislators. Those went to three Republicans and three Democrats as well a non-partisan Clerk of the House. We also gave a legislator a separate award 'Friend of NH Agriculture'. You will have to attend the Banquet tonight to learn who this year's Outstanding Legislator is. Recipient: Representative John O'Connor, Chair of the House Agriculture Committee.

It is now time to look forward. It is time to work on another Grange Day at the State House and maybe a side trip to the NH Historical Society's museum in Concord. It Is not too early to start planning another FLY-In to NH for the next Presidential Primary. That would only be 15 months away and takes a lot of coordinating with National.

Master's Address 2018

National Representative, Fellow State Officers, Honored Guests, Pink Sash family members, delegates and patrons all. Can you believe that we are here in Keene again? I feel like my journey in the leadership of the State Grange started here. First as the Youth Director for Beth Merrill when she was installed as the first female Master of the State Grange. Then four years later as I was installed as the Overseer of the State Grange and served under Past State Master James Tetreault as the chairman of the Executive committee. It is hard to fathom that this is the fourth time standing here presenting you with my annual Master's Address. What a long strange trip it's been and where has the time gone? It all seems like a blur now and it's really hard to believe that this day has arrived. I have learned and grown so much during my term in office and I am happy for the opportunity that has been given to me by the delegates of the State Grange. I know that none of this would have never been possible without the support of Grange members and family. Thank you all for this great experience and I hope that I have done you proud. Over the past four years I have learned to be a mediator, a witness, a real estate agent, an insurance agent, a landlord, a property owner, a representative, a moving company and a janitor. Don't let all these titles fool you, because by no means have I become proficient in any of these jobs. I never realized that I would need to learn so much. Who knew that being a leader of a non-profit fraternal organization would be so educational and expensive? It has been a long, hard road but I wouldn't have traded it for anything. It has made me grow as an individual and taught me that no good deed is achieved without hard work.

When I started this journey, I had a few goals that I wanted to complete by the end of my term in office. I feel that I have accomplished at least two of my goals and for that I am pleased. But there was one goal that I have failed to see to fruition and this worries me. I really wish I had been able to accomplish it during my term as your State Master. The goal was to see Granges

grow and gain new members. Now this statement is not completely true because we know that a few Granges have been able to take in new members and grow. I want to thank those Granges that heard the call and for doing their part to extend the life of the Grange. I applaud you all for your hard work and all I ask is that you keep getting more members. For those who have been unsuccessful, don't give up. Search different ways to work in your community. Be involved in what is happening and something positive will come from it. I know that many of you are tired but don't give up. You will eventually reap the rewards of your hard labor.

This has been another rough year for our Granges. Two more Granges have been closed; one for failure to pay their dues and another that has not had any meetings for the past two years. I attempted to work with these Granges because I didn't want to see them close but unfortunately nothing could be done to reverse these situations. In fear of repeating myself, this continuing trend is not good for our Organization and something needs to be done about this now. If we don't reverse the direction were headed we will lose even more Granges. There are at least two more Granges that are in desperate need of our help and if they are not successful in gaining more members, they might be the next ones that will be closing. The Granges, unfortunately, have not made any contact with the State Grange leadership for assistance. The leadership of the State Grange knows that they need the help but have our hands tied until someone asks for assistance. A new membership committee should be formed that can help invigorate new life into our Granges. This new membership committee should create a poll and send it to every individual Grange member in the state. This poll should be completely anonymous and completed by every individual member. This would help that new membership committee determine the best direction for the team to concentrate on and it would identify the areas that need improvement.

I wish that I never had to close any Granges but what good does it do to leave non-productive ones open? They set a bad example of what the Grange is and portray a bad image of our organization. All Grange members across the state who pay their dues are now paying the dues for these inactive Granges and that is not fair. Why should they not have to pay dues? Why should they not have to meet like other Granges? Why should they be allowed to not follow the rules? What was said or done that made these Granges think that this was acceptable? Where or when did they get told not to worry about doing the right thing? Have we all just made up our own rules on how we do things? Have we thrown caution to the wind and decided to throw the rules out the window? Do we think that we won't be held responsible for our actions? How did we lose all of this knowledge so quickly? I am the first person to admit that we need to change our Grange way of thinking but do we really want to change to this direction? Isn't this going backwards instead of forwards?

I wanted to have the membership of our organization learn to get along with each other. My personal goal was to make membership in the Granges in New Hampshire a desire of every citizen in the Granite State. I wanted to see the activity at state events increase to what they were 20 years ago. I wanted to see members forget their differences and get along with each other. I wanted to see each member embrace the values that our forefathers intended for us to hold true. I wanted for the members to rebuild those relationships that we used to have with each other and other organizations. I wanted to grow Granges. I wanted to do all of these things and I will keep working to accomplish them until the day I can no longer do so. I know that this is very self-

centered and that I won't be able to do this all on my own but it is my dream that someday the Grange will once again be a powerful force. If you can't tell I am very passionate about this and the future of our Granges, I hope that my enthusiasm and determination will spread to others and soon we will have so many involved in our movement that nothing will be able to stop us.

This past year I obligated our organization to be involved in RALI. I also, with the help of the National Grange Legislative director Burton Eller, signed a letter to Comcast/NBC encourage them to continue working on the Rural Broadband initiative. These are both very worthwhile projects that are right along with what the Grange is about. These are perfect ways for Granges to get involved with what is going on in their communities. The opioid issue in New Hampshire is way out of control and one of the biggest issues is the education of the people. This coalition of organizations are the perfect group to spread the word and teach the public about the dangers of these opioids. As part of this program, we have informational packets and disposal bags for each and every Grange in the State. The materials are printed and the bags are free of charge. The only things that the Granges need to do is work with another entity in town to help educate and distribute the bags. This can be a town hall, police station, public library or other public facing group. The material is free and all the Grange have to do is coordinate the supplies.

Many of our Granges in the state face a serious issue that needs to be reversed or it will be the end of the Grange in their area. This problem has been around for a long time and many people already know about it. Unfortunately, no one has ever made it publicly known and it has been swept under the rug all too often. What most people don't realize is that this has had a major impact on our image. What I am referring to is the viruses/cancers that are present in some of our Granges. These can be negative comments about other members, saying bad things about the organization, ridiculing the leadership on the local or state level as well as trying to tell others what they should or shouldn't be doing. There is only one authority in the organization and if there is ever a question about what it right, wrong or procedural, these should be brought up to the State Master, the Executive committee, the General Deputy or Deputy State Masters not Grange members doing whatever it is they want to do. If we have any hope of growing, we need to remove or treat these viruses/cancers. They are only going to bring us down.

Granges need to grasp the concept of being more social than social media. They need to use Facebook, Twitter, Instagram, web sites and other technologies to tell joe public about themselves and the good things that they are doing in their communities. They need to use their words and actions to spread the word about the Grange. They need to find a way to be more relevant to younger people. They need to find way to adapt and mold our programs and projects into what the youth of today are involved with already. Granges need to use these tools to spread our message. Only then can we graduate into the 21st Century and Show/prove that we are not archaic and irrelevant. Granges need to modify their behaviors and be acceptable to new ideas of the young people. They need to adapt but not lose their identities in the process. Then and only then will they be able to grow into what society needs.

Granges need to help bring morals back into our communities and families. Granges were once very active in the education of people and we really need to get back to this. Children in today's society are becoming mindless workers who don't know the meaning of a hard day's work. Too many young people are expecting everything to be handed to them for little or no effort. If this trend continues to evolve and is allowed, we will be in rough shape in a very short period of time. Grange is the place where people would learn the right and wrongs. Granges can accomplish this by being mentors and educators to the public. Teaching them skills and crafts that are soon becoming lost because not many people are interested in learning them. This is a place where we can start. There are many things that Grangers could teach to the youth of today. We claim that we have always been concerned about education. Well now is the time to show it.

We all know that Grangers are tired and many have been giving for many years. We are human and get discouraged but we have to keep on getting on. We have to keep trying to do the good work of the Grange. We need to have solidarity in what we do and our message. When we tell contradictory stories and make up rules as we go along, it sends mixed messages to the public as well as members in our community Granges. There are by-laws, resolutions and policy that the State Grange adopts. These are what should govern us. Members need to stop telling other members how to do things. Instead, we should be offering assistance and instruction that coincides with these guidelines that the delegates approve at our State and National sessions.

Granges need to concentrate some effort into making our halls family friendly. Maybe providing some activity for kids who might accompany their parents to meetings. We need to be welcoming to this new young families. We need to solicit ideas of things that they would like to do and then make a concerted effort to see these ideas to completion. These are going to hopefully be the leaders of our Granges in the future. We need to give them the tools and inspiration to continue the Grange work.

Communication is and will always be an issue. Grangers need to remember that communication is a two-way street. We need to be sure that we cover all aspects of a topic when we are communicating. Just like a good marriage, communication needs to be direct and forthcoming. Communications between all levels of the Grange need improvement. More and more we are doing more communication through electronic forms instead of the old way by sending mail. We know that not all rural areas of our State have access to the internet and electronic communication but at least one member of each Grange has email. It is up to these people to share the information. They don't necessarily have to be the ones talking about whats going on but they need to share the information so that members are kept abreast of what activities, programs and other important information is being distributed. This is also relevant for Granges who have members who have passed away or are sick. How can Granges send cards or make phone calls if they are now aware of what is or has happened.

It feels like the Grange has lost a lot of Do'ers. These are the core people who are always there doing the good work of the Grange. I understand that a lot of them are tired and are ready to go onto other more important things but we need for them to instruct, educate and motivate the new and current members to become Do'ers their own respects. Change is the word that we are all afraid of because of what it might mean for our future. We have become too comfortable in our own little shells and some of us don't want to do anything different. This is the wrong attitude and we need to learn to embrace change. Change is not always good and sometimes it can be a mistake but unless we try, we will never learn. We need to get out of the past and stop dwelling on what we have always done. Let's break free from these chains that seem to bind us to the

normal. Go out and do something new. Learn a new way of looking at situations and come up with new ideas on solving the same issues.

In conclusion, I want to thank some people who really have been helpful to me over the past four years. First, I would like to thank Kerriann. She has been my sounding block, my strength when I need it most. She has been my voice of reason and sometimes a source of new ideas. Next, I would like to thank my father Wilber Heath. He has provided so much advice to me through these past four years. He was there for me last year at National Session when I was in turmoil. He taught me valuable lessons that I will never forget. I want to recognize my mother Jane Heath for being that person who reminds me of the things that need to be done as well as that constant voice that says, "Have you done this yet?" My Grandparents Nathalie and Carryl Heath, for all of those times as a young person that they gave me the opportunities to learn about what it means to be a Grange member. Arthur and Beth Merrill for being mentors during my years in the youth department. The valuable lessons I learned from them are numerous. They have been a great source of knowledge and advice through these past four years. Kim and Dan Bascom for being there when I needed questions answered about how things should be handled. The delegate's whose vote of confidence has kept me going even though sometimes I was ready to throw my hands up and be done. Grace Leone who gave me my first opportunity to be in a leadership role so long ago when I was a member of Banner Junior Grange. Treasurer's Report

Worthy State Master Chris Heath, National Reps, Fellow Officers, Grangers All: A few years ago, I was accused of not being transparent with the financial status of the NH State Grange. I took this as an educational moment and informed this Granger that all financial accounts were published in the Journal of Proceedings each year and instructed her as to where to find one. With that in mind I have decided to do things a little different this year. I have stated in the past "I will not bore you with all the financial facts and figures". Well this year I am going to. So, sit back, buckle your seat belts and hang on as I take you through a wild ride of the invested funds of the NH State Grange.

When I was elected in 2012 the total invested funds in Morgan Stanley was \$835,169.00. As of Sept. 30, 2018, the total invested funds in Morgan Stanley was \$1,162,137.00. This has been accomplished by guidelines set up by Past Treasurer Gail Turcotte and the guidance of the

Executive Committee. Yes, I said \$1,162,137.00! Sounds like a lot, I can hear some of you thinking "then why does NH State Grange keep asking us for money". This does not all belong to NH State Grange, let me break this down for you. \$48,388.00 belongs to the Northeast Connection to help host National Grange Session in our region. \$33,396.00 is in the Defunct Grange account and is held for seven years. After that time if no new Grange is started in that area it is deposited into the State Grange operating fund. The Ex. Comm. has established a building improvement loan fund to Granges with Grange Halls with this money. \$163,166.00 is in the Education Loan Fund which is distributed by the Grange Services Comm. as educational loans and scholarships. \$29,915.00 is in the Randell Richardson Youth Fund and is used to help with travel expenses for our youth to National Session. \$72,359.00 is in the Trust Fund used to help Grangers in need. \$589,886.00 is held in escrow for Granges who have sold their halls. Leaving a balance of **\$225,025.00** in the operating fund of which we only use 3.5% of a 3-year rolling average. Which is **\$7,866.86** to cover all expenses for the year. Our proposed budget for this year is \$62,866.00. The rest of the money comes from your dues and other sources. Bonding fees are an in and out, bonding protects your secretary and treasurer. National Assessment is and in and out and helps National Grange with National Session expenses. The 3.5% of a 3-year average was recommended by Morgan Stanley and has helped us greatly increase our net worth. Our operating fund in 2012 was \$158,944.00 and is now \$225,025.00. An increase of \$66,080.00 in 6 years. I also use the 3.5% 3-year rolling average with all the other accounts accept the Northeast Connection. I thought this might give you a little insight into some of the financial working of the State Grange. Any questions?

Tuesday night I completed the epostcards for all Granges, it took me about 10 hours over two nights. The copy for your Grange is in your packet, If, for some reason you misplace it I can send you a new copy. I am doing this for each Grange to not have to reinstate you if you lose your nonprofit status. The cost for this is now \$600.00 wither you are reinstated or not. Would Cam Twiss please come forward. I worked with Cam this past year as her Grange lost their nonprofit status due to a change in secretaries. I am proud to present you with your first epostcard acceptance form sense your reinstatement.

As I have stated in the past, I don't receive all financial statements until about October 15th, this leaves me very little time to complete my financial report for year end. All financial figures will be printed in the journal.

I have discovered another project for me to work on, I need to stay off the computer as last spring I found a state web site that lists all Granges who have paid their State of NH nonprofit status and again found many who now need to be reinstated before 2020. Those of you who are affected will be contacted for information so that I can get you reinstated. This is the \$25.00 that you pay to the state every 5 years.

I would like to thank each and every one of you for the confidence you have entrusted in me and thank you for asking me to serve as your Treasurer.

State Secretary's Report 2018

Worthy State Master, National Overseer, Delegates, Brothers and Sisters

As I sit here and write my sixth report to you as your State Secretary I can't help but wonder where the time has gone. It seems like only yesterday I stood before you and presented my first report.

So much has changed in these last six years. Some good and some not so good, but through it all we have always remained committed and dedicated to this remarkable organization that is inclusive to all.

Subordinate Granges:

We began the year with 54 Subordinate Granges and a membership number of 1431; Barnstead Community Grange was closed effective June 30, 2018. West Thornton Grange closed effective July 10, 2018. Pleasant Valley Grange was closed. Prentice Hill Grange consolidated with Golden Rod Grange and Halestown Grange consolidated with Joe English Grange effective September 30, 2018. Daniel Webster Grange and Winthrop Grange were both closed as of December 31, 2017. Leaving us with 46 Subordinate Granges, leaving us with a total membership of 1279 giving us a loss of 152 members.

On a positive note the following Granges did have a gain in membership:

The largest Subordinate Grange is Wicwas Lake Grange #292 with a total of 88 members.

There are several Subordinate Granges that are currently behind on reporting and owe past dues to the State Grange and others that are not meeting regularly or holding meetings as prescribed by the By-laws of the State Grange. I will be making recommendations to the State Grange Executive Committee on how to get these Granges in compliance.

Pomona Granges:

We currently have a total of 8 Pomona Granges with a total membership of 389. A loss of 84 members from last year. It is important to note that this loss is due to the number of members being suspended.

Pemigewasset Valley Pomona #18 is the only Pomona with a net gain in membership giving them the distinction of the largest Pomona with 89 members.

My first priority following State Session was to finish assembling the 2018 NH State Grange Roster. I am happy to report that it was ready for Deputy School in December. This is always a monumental endeavor requiring many hours of inputting of names, addresses, E-mail addresses, and phone numbers. Most Granges did submit a form so very few pages were left blank.

As with any document there needed to be some corrections and updates. Roster corrections were sent to the granges and hopefully made it to the Masters and Secretary's copies. I am asking all secretaries who have not yet sent in the new form for the coming year to please make sure that

this from is filled out clearly and sent by the November 1st deadline. Most of the corrections that needed to be made were because the information was difficult to read. For those who have sent the form already, thank you. If something is not clear you will be receiving a call from me.

There has been some discussion both publicly and privately about the need for printing a Roster. I am required to provide two copies to each Pomona and Subordinate Grange and one to each member of the State Team. Over the last six years the format of the roster has changed and the current one seems to be the preferred format. However, this format is not one that can be moved to the State Grange web page so this may change. I will be working with the Web Master to come up with a format that will work for both printing and placing on the web page.

The Journal of Proceedings for the 144th Annual State Grange Session was completed and ready for distribution in early January. I have usually had the Journal completed by Deputy School but with the Roster taking up so much time I was unable to get it completed.

Having the journal completed quickly remains a priority to me so that those wishing a copy can receive one while the session is still fresh in their minds. I'm pleased to report that several Granges requested a copy of the journal as well as others who asked for a personal copy. The Journal was submitted and placed on the NH State Grange web site and hope that many of you reviewed it.

Near the end of each quarter a packet was sent to each Pomona and Subordinate secretary with information for the members as well as the usual report forms. I can't stress enough how important it is to complete the reports and send them in on time. What we pay to National Grange is based on the membership numbers from these reports. If I don't receive a report from a Grange the membership number, I use on my report is the number last reported. There have been times when a Grange report was submitted after my deadline to National and the Grange reports a loss of members. If these reports were sent in on time, we wouldn't have needed to pay dues on the lost members now being reported. I also need to stress that it is extremely important that the dues check accompany the report. Several granges are sending these separately which requires unnecessary documentation.

In an effort to encourage each grange secretary to report on time and every quarter I will be instituting an "Honor Secretary" award and will make a recognition at next year's Session. Information will be sent in a future mailing.

As the Secretary it is our duty to keep our members informed and this is done with the reading of communications. I am requesting all Secretaries to read what is sent to your Grange. I am requesting that each Subordinate and Pomona Secretary and committee chairman establish the following philosophy, if a communication is important enough to send to your Grange it is important enough to read it to your members. Some of what is sent can be lengthy and for that I am sorry! The communication doesn't need to be read word for word, giving highlights is fine as long as the important information is shared.

The supply department continues to be very busy filling orders. I am very pleased to report that most are using the order form. This has really assisted me in ensuring that all orders are filled

and sent more efficiently. Receiving of membership award and supply requests on scrap pieces of paper or in an e-mail has ended. There are going to be a few revisions made to the form so please look for those changes.

State Session is once again approaching and with that comes the preparations associated with it. The program was created, printed, and folded, resolutions formatted, printed and collated, ribbons ordered, delegate packets assembled the list goes on and on. I must admit that while this seems to be overwhelming, I find it exhilarating and look forward to the whole thing coming together.

In conclusion there are some people that I would like to thank for assisting me with all that comes with this position. First, my daughters Sarah and Emilie for all you do. Whether it be proof reading, a computer question/issue, stuffing and folding or taking on the Credentials for session. Believe it or not, there are times when dad gets cranky and you always find a way to get me through it. Thanks! Love you both! I would like to personally thank each Pomona and Subordinate Secretary for the time they take in their busy lives performing the duties of this office. State Master Chris Heath for being available when needed. State Ceres Kerriann Heath for taking charge of the banquet this year especially. And finally, to the delegates who had faith in me and bestowed the honor upon me to be your State Secretary for the past six years. I look forward to continuing to serve the State Grange in whatever is asked of me.

"Said Historian to be charges with the responsibilities of collecting the records of defunct Granges not now in the possession of the State Grange, cataloging the records, inventorying the memorabilia, setting up a library and generally keeping an oversight on the records and history of our State Grange and those Subordinate, Pomona and Junior Granges that have through necessity given up their charters. Said Historian to be authorized to wear the pink sash of the State Grange family, similar to that of a State Officer. Said Historian to be appointed by the State Master. The committee further recommends that a search be made for a suitable place in which to store these archives, and that the State Secretary of the New Hampshire State Grange be urged to give due assistance to the Historian."

- Recommendations from The Masters Address Committee 2017: 1) Add Publicity as a line item in the Budget and allocate the necessary funds. Worthy Master, Brothers, and Sisters

Another year has passed, and once again we meet here as a state grange to reflect upon the past and consider our future. It was another difficult year, but most of you are familiar with the challenges that face us so I'm not going to dwell on them. This will, of course, lead to my report being shorter this year, but I feel that more gloom is not going to help us right now. Maybe focusing on what we did well over the past few years will give us some hope, and ideally encourage some of our granges to put in extra effort in the future. We still need to do whatever we can to help our granges grow, and it is important to remember the lesson from the fifth degree: Hope and Persevere.

Subordinate Granges

This year I received reports from roughly 75% of the subordinate granges. This percentage could be improved by getting some new volunteers to join the deputy force. I strongly encourage anyone that might be interested in helping us to contact me. Even if you can only visit one grange (twice a year) it would be greatly appreciated.

Grange ritual is still alive and well in our state. Over 75% of reporting granges have enough active members to perform opening and closing rituals. That may not sound amazing, but it's actually an improvement from where we were three years ago. We also have granges that are still willing to exemplify subordinate degrees, which allowed a couple of granges to score some extra points this year. When it came time to demonstrate balloting for candidates, over 60% of the granges rose to the challenge. Although the execution itself sometimes required assistance from the deputies, the granges were willing, and sometimes eager, to tackle this challenge.

Reports this year indicate that there may have been an increase in membership. As has been noted in the past, there is sometimes a discrepancy between what the granges write on their

deputy reports, and what they submit to the state secretary. I am hoping that the secretary's reports this year show a similar increase in membership.

Over the last four years, we have tried to emphasize the important duties that certain officers have within their granges. We have done this by having the deputy read those duties to the grange as a whole in the spring, and asking that officer to recite them again the fall. If the number of granges participating in this effort is any indication, then our efforts have been increasingly successful over these years.

I have spoken before about our efforts to challenge the granges to complete a membershiporiented goal that would take them outside of their comfort zone. I was pleased to note this year that more granges succeeded in completing these goals, and hope this is directly related to the reported increases in membership. If you are considering doing something that would increase exposure in your community, but are lacking in required funds, consider requesting financial (or even manpower) assistance from another grange. The average grange has over \$3,000 available, and what better way to spend it than in the interest of growing the grange? This year I will again recognize the leading scores in both small and medium grange categories. These categories are based on total membership of the granges whose reports reached me in a timely manner. The top scorers are as follows:

Small granges: 3rd place – Claremont Grange 2nd place – Antrim Grange 1st place – Baker's River Grange

Medium granges: 3rd place – Blazing Star Grange 2nd place – Wingold Grange 1st place – Blow-Me-Down Grange

Congratulations to these granges for the work and effort they have put into this organization over the past year and I hope they continue to do well in the future.

Pomona Granges

As most of you have probably noticed, there is once again a resolution before the state grange regarding the fate of the Pomona granges. I have shared the views of both myself and the Pomona deputy in the past, and feel that reiterating them now is unnecessary as there should be plenty of discussion about it soon enough. The delegates should have their chance to decide the future of the Pomona granges themselves this weekend.

We did hold a meeting last month that allowed Pomona members to respond to a list of five important questions about the Pomona granges. These were presented by our state master, and led to some lively discussion. I hope this also leads to some real decisions being made this weekend.

None of the Pomona granges exemplified the fifth degree this year, but I have heard that some have plans to do so in the future.

The highest scoring Pomona grange this year was: Suncook Valley Pomona

Conclusion

I need to thank all of the deputies who continue to volunteer their time and expertise. Their commitment to this organization is the only thing that makes this job possible. I suspect that some of them would like to retire, so again I want to call upon anyone who is interested in helping us to contact me about becoming a part of this team. I know it can be a time-consuming task, but believe me the welcome you will receive when visiting a grange will make it worth it. Fraternally,

Richard Patten, State Historian was escorted to the Master's station to present his annual report:

Worthy State Master, National Representative, State Officers, Patrons All,

It doesn't seem possible that another year has passed and we return to the City of Keene. A lot has happened in Keene since the last time we were here. Keene has become famous for the Pumpkin Festival until some incidents forced them to curtail it. However, it has spurned several other communities to organize a Halloween/Pumpkin Festival in their locations. However, Keene has since come back with their own pumpkin festival. The State Grange has met in the City of Keene several times throughout the history of this organization.

I was reading the 1968 Journal of Proceedings which the state session was held in Conway and the Secretary's report showed 220 Subordinate Granges with 16,187 members, a loss of 749. There were 26 Pomona Granges with a membership of 7,119 members, a loss of 324. There were 21 Junior Granges with 681 boys and girls, a gain of 37. I found that the State Grange Banquet or the Century Farm Awards Banquet celebrated its 30th anniversary making this year the 80th anniversary. There were farms throughout the state that had been in the same family for one hundred years or more. Honored guests from the University of New Hampshire or NH Department of Agriculture would attend the banquet and spoke about the farm or farms being honored.

I read the New Hampshire Youth Degree Team exemplified the Third Degree. The officers included, Master, Raymond Tucker; Overseer, David Enman; Lecturer, Pauline Simard; Steward, Lamont Bickford; Assistant Steward, Henry Jones; Lady Assistant Steward, Alice Heath; Chaplain, Lois Enman; Treasurer, Rolf Staples; Secretary, Alice Jane Bickford; Gatekeeper, Denise Chagnon; Ceres, Karen Johnson; Pomona, Roslyn Heath; Flora, Janice LePage; Executive Committee, Steven Libby, John Kusnierz, and Clayton Tuck; Pianist, Mildred Chesley; Soloist, George Hall; Tableau, Ruth Geralds, Alice Staples, Roseanna Kusnierz; Harvesters and Gleaners, George M. Standley, James Hadley, Robert Lowe, Barbara York, Gloria Heath, and Ellen Manley. The candidates were Ernest Jones Jr, David Jones, Mary Shea, and Priscilla Hall. Looking at that list of names brings back a lot of memories. I also found that Herbert West was elected State Steward for one year due to the untimely death of the late The top five Pomona Granges in their district were: District 1, Randall Richardson. Ammonoonsuc Valley; District 2, Mascoma Valley; District 3, Union Pomona; District 4, Hillsborough County Pomona; and District 5, East Rockingham Pomona. The Top 5 Subordinate Granges in the state were: 1st, Sugar River Grange of North Charlestown; 2nd, New London Grange; 3rd, Cheshire Grange of Keene; 4th Ezekiel Webster Grange of Boscawen; and 5th, Monroe Grange. There were 103 candidates who received the lessons of the Sixth Degree.

I was reading the 1988 Journal of Proceedings. The session was held in Lebanon and it doesn't seem possible that it was 30 years ago and I was serving as State Lecturer. The Secretary

reported 132 Subordinate Granges with a membership of 7, 6881 members. There were 24 Pomona Granges with a membership of 3,590 members. There were 165 boys and girls in the Junior Grange. The sixth degree was conferred on a class of 48 candidates to receive the lessons of the Degree of Flora.

This year has been another busy year. I didn't get a chance to deliver as many Secretary Minute Books to the Historical Societies as I would have liked. There are about 48 boxes of books left at the State Grange Building. I am hoping this year to finish this project.

I have received twelve requests to do research on deceased members. I checked roll books that I have and many times the name in question had changed their last name. I had one request to check a name as this Grange was convinced that the deceased member in question was a Past State Master. I looked through all the books I have and finally figured out that this member served as a Subordinate Deputy. At one time, when a Deputy came to visit a Grange they were introduced as Deputy State Master. I called the member of this Grange and explained what I found. I enjoy doing research for a Grange or someone looking to find a relative. This year as reported by the State Secretary, we lost some members who wrote history without knowing it. I had the pleasure of knowing some of our members who went to the Great Grange above.

I read an obituary for Ella Mae Lee Cochrane who was 84 years old. In her obituary, it was listed that she was proud of her many years of being a member of Merrimack River Grange of Canterbury and then transferring to Pineconia Grange when Merrimack River closed. I have been unable to locate the Roll Books and Minute Books for Merrimack River Grange. I hope to locate them this next year.

Edwin & Jeanette Huckins were members of Squam Lake Grange in Ashland and then transferred to Harmony Grange of Sanbornton. The Huckins family were very active members in earlier years in Squam Lake Grange, Edwin served as Master and Jeanette held office as well. It was sad to see them both pass to the Great Grange above.

I was reading the Union Leader and noticed the passing of Gerald Stoddard of North Haverhill. I found his obituary very interesting. It mentioned he was the 1957 NH State Grange Farmer of the Year. He was also Past Master of Pink Granite Grange of North Haverhill and then joined Mount Gardner Grange of Woodsville. He was the last surviving member and longest serving Vice President of the North Haverhill Fair Association. He and his family owned and operated Blackmount Farm for many years. He held membership in the Farm Bureau, NH Fairs Association. He enjoyed dairy farming and wintering in later years in Florida. He was honored as Director Emeritus recently for his many years serving the North Haverhill Fair.

Roland Barrett: I first met Roland in 1972 when I was completing my year as State Prince. Roland & Carole were candidates for Young Couple of the Year. They were selected to represent New Hampshire as the Grange Young Couple. It was apparent that Roland enjoyed working with the teenagers and young adults. He was appointed to the State Youth Committee, of which he served for many years. He served as Master for Golden Rod Grange, Cheshire County Pomona Grange and as Patron/Leader for Golden Rod Junior Grange. Roland had several health issues but he refused to let that keep him down. Roland you certainly earned the title, well done, good and faithful servant.

Donald Murray was the oldest son of the late Helen and Jess Murray who operated Murray Farms in Penacook. Don was a 65 years member of the Grange and Past Master of Riverhill and Halloween Juvenile Grange. Donald was quiet but he knew his horticultural skills and he worked many h ours in the green houses.

Cecil White was a Master at Millville Grange of Concord. When Millville Grange closed, the members went to Bow Grange. He and his family were active members of Grange Then when Bow Grange merged with Pineconia Grange of Concord Heights, Cecil and his family continued their Grange membership. He became a greeter at Wal-Mart always smiling and speaking to everyone.

Nancy Bean was a very active in Grange. She and her late husband lived in Concord even though they held their Grange membership in Contoocook Grange. Nancy did a great job as Lecturer for her Granges. She would participate at New England Lecturer's Conference and would always do whatever she was asked to do. She served as State Family Activities Director for past State Master Beth Merrill.

Nancy could always be counted on her and you knew when she smiled, that she would give her all.

Carroll Leone will always be remembered for that great smile and always willing to help Grace with Banner Junior Grange or when he was appointed State Agriculture Director for Past State Master Dan Bascom. Carroll was a quiet guy but a very busy worker for his Grange. He took his duties as State Agriculture Director very seriously.

I met William Humphrey when he and Barbara along with a couple of members from Hampton Falls Grange came to a Youth Night at Pineconia Grange. We were having a special program asking members to come dressed in revolutionary war period. He was very good natured and loved to laugh. He served as a Subordinate Deputy, then became General Deputy for Past State Master B. Franklin Hayes. He was elected to State Gatekeeper and then after a few years, he attempted to run for State Lecturer. However, that effort was unsuccessful and he finished his term as State Gatekeeper and retired. He has served as Master for Hampton Falls Grange and active in East Rockingham Pomona.

Just recently we lost Jeannetta Whitford, who was a member of Daniel Webster Grange and traveled with Marion T. Jones to Grange meetings, Webster Women's Union and Church meetings. She would help on suppers at Daniel Webster Grange and Marion knew if she asked Jan to help, she would not refuse. In recent years, Jan's health problems made it necessary for her to be admitted to a nursing home in Peterborough. Her husband Clarence had died years earlier and was buried at the NH Veteran's Cemetery in Boscawen. She requested to be buried with him at the Veterans Cemetery.

Forest Decatur is another member whom I was very surprised to see that he has left our midst and gone to the Great Grange Above. I first met Forest when I was Prince and traveled to many meetings with Bob Perry. It was not too often in those days that we traveled out of our home area except to attend a meeting. When I met Forest, he was quiet but friendly. He belonged to Wingold Grange and within a few years he had become a married man. Forest and his wife Estelle "Dusty" were named Young Couple of the Year in 1974 for 1975. Forest was very active in the town of East Kingston not only with the Grange but with the Fire Department and keeping busy with his children. He will certainly be missed by all who knew him.

Ruth Pelton was called to the Great Grange Above just recently. I first met Ruth in mid-1971 when she was visiting Granges in hopes of becoming a State Officer. She was appointed to the State Membership Committee and served on that committee for few years. She also served on the State Home Economics Committee for a few years. She belonged Hampton Falls Grange where served as Master among other officers. Her late husband, Ken passed away several years ago. Ruth also belonged to East Rockingham Pomona Grange. She loved to bowl in the Grange Bowling Tournament. I read her obituary and she was very involved in the 4H serving as a Leader for ten years. She loved to sew and entered many items in the Grange sewing contests. Her smile and quiet voice will be missed by many in the Grange and in Hampton Falls.

I know there have been others who have written history in their Grange. I also know their Grange will miss them and what they contributed to the organization. On a happier note, it was nice to celebrate some good news. Isabell Bartz, who has been a member of Bartlett Grange in Salisbury and now a member of Concord Grange celebrated her 100-year-old birthday with surprise party in Salisbury. Dorothy Bartlett, who was Matron of Bartlett Junior Grange for many years celebrated her 90th birthday.

This year marked the 90th anniversary for the beginning of the Juvenile Grange in New Hampshire. State Junior Grange Director Joann Brandt organized events to mark this special anniversary. The Juvenile/Junior Grange was very active and wrote much history outlining the accomplishments of the boys and girls. We were very lucky to have some very dedicated Matrons and Patrons who spent many hours with our Juvenile/Juniors. I was honored to be appointed the first male Junior Deputy and then the first male Junior Director in our state. I will not talk any more about this as Junior Director Joann Brandt will be talking about this in her report. I will say that I am honored to see Chris Heath as State Master, as he was Junior Master of Banner Junior Grange when I was his Junior Deputy. I am also pleased to see Sara Leclerc, Mary West, Anne Louise West, Sandra Bokousky, and Emilie Leclerc who were Junior Grange members and now making a difference in the Subordinate Grange.

I have been asked many times the whereabouts of some of our past members. The computer helps me in many ways to locate people. I have located Bill Jeralds, who is living in Pittsburg, NH. John Critchett, is living in Florida and celebrated his birthday recently. I had a great time talking to James Hadley, who is living in North Carolina. I have been trying to locate Peter Brown and his family. I have enjoyed writing to Rolf Staples, who is living in Maine. He fills in some missing blanks every so often. Does anyone know what happened to Richard Seaver, Erwin Reynolds, Ernie Jones Jr., Stephen Libby, Donald Shattuck, Patricia Dustin, Linda Hall, Priscilla Hall, and Linda Corey? I have also been asked what happened to Pauline Simard, Beverly Woods, Carol Fortune and more. I appreciate the nice comments on items I have written in my State Historian page on Facebook, I enjoy reading on past years I have been a member of the Grange. I have been working on a current NH State Grange History Book. My version is memories of what I have encountered since I have become a member. How many remember Corresponding Officers Night, Presiding Masters and Lecturer's Night, Presiding Masters and Past Masters Night, Presiding Overseer's Night, Pink and Green Sash Night, Booster Night, and Neighbor's Night. These were just a few special theme nights that were held throughout the state.

I am hoping my book will be proofread and sent to be printed by the end of November. It is amazing how many people you talk to and they have no idea that the Grange is still alive. Saturday, October 27, 2018

The third day of the 145th Annual Session was opened in the fourth degree at 8:30 am by the officers of the NH State Grange.

Brother's and Sister's and delegates alike what a year it has been.

This past year I had added 1 new member to the Ag committee, Scott Burns. Thanks to him we put on a pruning workshop. We had a little over 20 people in attendance, sadly only 5 of us were Grangers. David Quigley, of King Street Vineyard in Milford hosted us on his very small property brimmed with all types of fruit trees and grape vines. Starting with Grape vines he demonstrated proper cutting and care for great grape production. Followed by peach, plum, blueberry, blackberry, Raspberry, and Apple. All followed by a raffle that he had set up with quite a few of the people getting free Grape vines, a grow bag along with a gift certificate for soil from a local grain store.

My Neighbor that lives across the street from me was one of the participants and, also one of the lucky people that won a grape vine. I will say that the Grape vine he won is doing much better than the ones he had purchased from stores after the program. We had also used some of the pruning knowledge we obtained to tame his grapes, he had been trying to grow for the last 6 years, to find that they produce nice large clusters when tamed!

Once again, this year we did Farm and Forest Expo in Manchester. Les Avery once again was a godsend as he came and helped a lot. I also had Adam, and Scott helping with the Masses, and the masses came! This year we had baby chicks for people to hold and learn about chicken breeds and how to sex, sex-linked chicks. We even had Governor Chris Sununu and the Commissioner of Agriculture, Spencer Jasper, there to learn this trick. Over all everyone that helped made it possible and I appreciate the help.

This year found me doing much more at the house than I had expected seeing I had sold many of my animals in late winter to give me a chance to get some stuff I wanted to get done, done. Unfortunately, my brother didn't get the memo and I would get calls all early spring, Hi I'm on the way from Vermont with 2 goats, oh wait nope 10 goats. Or I'm on the way from New York with a Holstein Heifer, no it isn't weaned off, but it is bucket trained. Hi Norman you may find in one of your pens I left 75 baby chicks, can you get the light on them and feed and water them? With so many animals showing up, unexpectedly, it always left me scrambling to get stuff done. He was getting all these animals for his children to show at the fairs, and I took them in and care for them for his kids are going thru a lot and they need some way to release, but it would be nice if he helped a bit more, but that isn't here nor there.

With the increase of animals, the spring thaw and a booming rodent population across the northeast, I was confronted with a new dilemma, the Police chief in town decided to contact the SPCA due to someone seeing a rat on their morning run and not liking an odor that my neighbors still tell me they haven't smelt. The SPCA and the police chief showed up as I was at another Grange members house getting ready for the Ham and Bean supper our Grange was putting on the next day. After much threatening and me knowing the animals are in good condition I let the SPCA investigator in. He had many problems with the watering systems I use for my livestock, telling me open water sources, dishes and troughs, I don't think the animals know how to use the water nipples and if you don't change things quick we'll be coming with channel 9 and trailers to take the animals away. A week or two later the police chief showed up once more telling me, "I'm a computer guy, I'm sure I can find a law you don't know about to charge you with if you don't get these changes made". To which I had told him if he is so eager to arrest someone I know two people that had broken a law a week or two ago and I'm sure he could get a conviction for both and the State Vet wants to know why neither of them have contacted him to that day as the law required them to do with a farm. This is the reason in the new Ag program I have broken down what to do if you have problems. In the end I still have the animals and a letter from the State Vets office saying everything is all set.

While talking about the program book, this past year I did not get a single suggestion submitted by a Grange, a few Grangers have submitted some information, but none with vetted by their home Grange ahead of time and I would like to emphasize the fact that the first contact for a recipient should be a local Grange. Make it a big deal you are putting them up on a pedestal for all locals to know their farm has been active doing, or surviving for X number of years. Then submit their name to be recognized by the State Grange. If we are only recognizing them at State Grange and not locally how is anyone going to learn what a Grange is and what we do?! In conclusion, I hope this coming year goes better than this past year, for everyone not just me. And I would like to thank my Committee members and the State Master for all the support they have given me this year.

The Granite State Granger Report for 2018

In 1776 it could take a written message three months or more to reach its destination. The message could be hard to understand because spelling was not standard, and handwriting was not always clear. Today a written message can be transmitted in a few seconds. The message can be hard to understand because of typographical errors and abbreviations, or because voice-activated text does not always record what was actually said. Has communication really improved in nearly three hundred years?

The Grange straddles the line between 1776 and the present. Our messages are better spelled, but not fast or frequent enough.

I have in my hand a copy of the <u>Granite State Granger</u> for April 1955. It is a little magazine measuring 9 inches long and 6 inches wide. It was printed on shiny paper in Hampton, New Hampshire, and mailed from the Post Office there. It sold by subscription for \$1.50 per year to the public and \$1.00 a year to Grange members. It was also supported by advertising from The Merrimack Farmers' Exchange and the Grange Mutual Fire Insurance Company. It was published monthly. Twenty years later in the 1970's the format had changed to 8 ½ by 11 inches on sturdy paper. It was still sold by subscription. There was one ad from the Grange Mutual Insurance Company. There is no indication of where it was printed. It was published monthly at first and then changed to every two months.

In the 1990's the format changed again, this time to newsprint in a newspaper format where it remains today. It is published quarterly and printed by <u>The Concord Monitor</u> Commercial Department. There is no advertising and no subscription fee. The publication is paid for by the New Hampshire State Grange and is considered a dues benefit. It is supported in part by donations from members. All New Hampshire Grange members receive the publication, but they receive it less often.

Now, as we approach 2020, is it time for another change? The newspaper format does not hold up well to modern mailing practices. Postage costs are rising, in part because of inflation and in part because in most cases we no longer have 150 papers going to the same three-digit zip code address. Papers boxed with mixed zip-codes cost more to mail. Automation at the Postal Service is rough on items that are not mailed in envelopes. The folded paper must be held together with wafers which are an additional expense. Have you noticed that many magazines now arrive in plastic wrappers? Now and then a very frazzled <u>Granite State Granger</u> is returned to me. Non-

profit mailings are not required to be returned if they cannot reach the addressee, and I wonder how many other papers are out there in shreds.

One obvious answer is an electronic format. The news can be transmitted without going through a printing company or the Postal Service. If the <u>Granite State Granger</u> can be submitted to the printer in electronic format, it can be transmitted to readers in the same way. It is no more difficult to update an e-mail list than it is to update mailing labels. Incidentally, we Grangers are not the best at keeping our contact lists up to date. It is October 2018; do you know where your members really live? An electronic newsletter could be sent out more often, so the news would be more timely.

Sounds good, doesn't it? However, there is a minus side. There are still members out there who do not have computers at all or do not have-up-to date technology. There are members, and I am one, who do not choose to read their information on line. The <u>Massachusetts State Grange News</u> appears on line monthly. I have not read it since they switched to that format, which is sad because it is very well done. Would your Grange department directors have the time and energy to send in news more often? Would someone be willing to work on <u>The Granite State Granger</u> nearly every day all year? We have difficulty keeping our website up to date. Are we ready for faster communication?

I suspect there are other alternatives or a combination thereof. I <u>know</u> that I have reached the limits of my expertise and creativity. If the <u>Granite State Granger</u> is going to move in a different direction, someone else needs to move it. Think about it, people. Is there a New Hampshire Granger out there who is willing to take on the communication challenge?

Beth Merrill and Dawne Hugron stepped up and helped by cleaning the building on a regular basis which was wonderful. Arthur also helped by mowing. Members of Suncook Valley and Hillsborough County Pomona came together to do quite a bit of work on the landscaping around the building in early summer.

Critical things such as getting the occupancy permit renewed and the fire extinguishers inspected were done. Fortunately, not much inside maintenance was really needed, as my unexpected separation from the maintenance half of the building manager team led to not much getting accomplished on that front.

No group is currently using the building on a regular basis. We have rented the building several times again this year to members of the NH Nepali community for various events. There have

also been a handful of Grange events and committee meetings held at the hall. Ideally the building would get more use, and it is my understanding that a committee is currently working on ideas for that.

Now is the time to stop this downward trend and make the Grange great again!!

This is my final report as your Community Service Director for the NH State Grange. I will admit I am very sad as I have truly enjoyed this position very much. I will always thank Alice Heath for asking Past State Master Jim Tetreault if she could ask me to do Community Service. I was truly honored and humble. Community Service is a very important Standing Committee. It was twenty years ago that NH State Grange submitted a resolution to have Community Service designated as a Standing Committee on the National Grange Level. I was truly honored to be appointed the first National Grange Community Service Director. The Granges in New Hampshire should be proud of the work their members are contributing to their community and possibly a neighboring community. The Granges are also honored for working with another organization that would welcome some assistance. Granges working together with other organizations are to be congratulated for not looking the other way.

This committee sent greeting cards to Liberty House for all the special holidays and at Christmas, they were given a card with a movie ticket to CineMagic in Hooksett which also includes popcorn and beverage. I know other Granges remembered the veterans at the Tilton Soldiers Home. I placed a wreath at the State Grange Monument in the Veterans Cemetery in Boscawen for Memorial Day.

The National Grange Director stresses that books are not supposed to enter photos of the Sixth Degree Court of Flora, State Grange Banquets, or going to State Grange special events. They do not feel this is community service. The judges told me how much they enjoyed the many projects these Granges have done. Mount Hope Grange of Landaff, being a smaller Grange showed how much they did for the citizens of this small community.

Some of the Grange projects that stood out included Blow Me Down Grange's Attic Shop; Claremont Grange members were involved in Lending a Helping Hand with the Girl Scouts, Women of the Moose, Community Christmas Dinner, Making Fleece Blankets for Nighty Nighty Hugs Project, High School Alumni Parade; Hampton Falls Grange continued their important project with the Pease Greeters; Mount Hope Grange in Landaff continued their support of the Memorial Day – Lilac Festival; they also conducted a roadside cleanup, Mount Hope members go Christmas caroling, baked homemade cookies for the town residents who came for a community Christmas Night. Concord Grange continued their support for the 67th annual Concord Christmas Parade, Concord Christmas Tree Lighting, Dictionary Project, Easter Egg Hunt expanding it to another city park; and Recognition Awards Night; Wicwas Lake Grange was heavily involved in the Save The Steeple Fund for their community church; Antrim Grange participated in the Festival of Christmas Trees, this Grange also held a community supper for the holiday season. Resolution #1 Submitted by: Hudson Grange #11 Subject: Future of Pomona Granges in New Hampshire

WHEREAS, the number of Pomona Granges in New Hampshire have declined from 11 reported in 2013 to 8 as reported in 2017. Showing a loss of 3 Pomona Granges.

WHEREAS, the number of members have gone from 680 to 473 in the same time period leaving the State of New Hampshire with a loss of 207 members.

WHEREAS, interest and involvement in the Pomona Grange in New Hampshire has declined preventing Pomona Granges from properly conducting meetings and conferring the Fifth Degree.

WHEREAS, the distance members need to travel to attend a meeting may be a deterrent for them to be more active

THEREFORE, BE IT RESOLVED, that the Pomona Degree be retained as a requirement of membership to the Sixth Degree, and be conferred by a Fifth-Degree team comprised of members from Pomona Granges at a time and place prior to the annual NH State Grange session for the next three years with the expectation of a gain of 50 "NEW" Pomona members.

BE IT FURTHER RESOLVED, that if this resolution passes, and the expectation is not achieved, ALL Pomona Granges in NH will be closed as of October 31, 2021. All assets of Pomona Granges effected will be held by the State Grange in an account while a fair and equitable use of the assets can be determined.
Recommendation:

There has been a differing of opinion among the nine surviving Pomona's as to what to do with the declining membership and numbers of Pomona's in the state. This resolution is an attempt for action. In effect, the Pomona's have three years to grow membership. If that fails, then the Pomona's in the state will be dissolved.

There are some states with no Pomona's. Some with only one Pomona, whose main duty is to confer the 5^{th} Degree.

We thought that this is an opportunity to keep the Pomona's by growing numbers. If that happens, then it would be a positive thing.

The vote was unanimous vote in favor

Resolution #2 Submitted by: Wingold Grange #308 Subject: Implementation of the +1 Junior Grange Program

WHEREAS, National Grange has implemented a new Junior Program called a plus 1,

WHEREAS, Grange members look to our by-laws for direction and,

WHEREAS, our current by-laws do not reflect the new Junior Program,

BE IT RESOLVED, we amend our By-Laws for Article XV by adding Section 7 to say National Grange 1 + Junior Grange program Guidelines for the NH State Grange

If a Junior Grange is not available, an individual between five and fourteen years of age may be proposed as a candidate for membership as an individual Junior member of a Subordinate Grange and therefore become a member of the NH State Junior Grange by doing the following.

- a) Submit a Junior Grange application signed by the child's parent or guardian for Junior membership through a vote of the Subordinate Grange <u>to the State Junior</u> <u>Director or the State Secretary if a Junior Director has not been appointed</u> accompanied by the \$1 application fee plus the \$1 junior annual dues.
- b) Full membership to the Junior Program is attained by the candidate upon conferral of the Junior Grange Obligation Ceremony or Junior Degree.
- c) Junior Grange Leader: The subordinate Grange shall appoint a Junior Leader to meet with the Junior Grange member(s) once per month. The Junior Leader must be a fourth-Degree member. If the Junior Leader is not the parent of guardian of the child, the Junior Leader must complete a State Grange CORI form and submit it to the State Secretary for processing and approval.

Duties of the subordinate Grange's Junior Leader:

- Meet once per month with the Junior member(s)
- Using requirements for the State Junior Grange Members and the State Grange Program Handbook, provide appropriate activities to be done during the Subordinate meeting and/or at home between meetings.
- Keep Junior member(s) informed of upcoming Junior events and deadlines.
- Encourage Junior Member(s) to attend the State Junior Day to experience an actual Junior Meeting and the Junior grange Ritual.

Recommendation:

This is already policy. It's something that was adopted at the National Grange Meeting in Manchester. This resolution will simply incorporate it formally into our state By-laws.

The vote in favor of this resolution was unanimous.

Resolution #3 Submitted by: Mt. Pistareen Grange #145 Subject: Incorporating today's technology to allow members greater inclusiveness in New Hampshire Grange meetings.

WHEREAS, the continuation and well-being of the New Hampshire State Grange depends on a strong membership in order to survive and thrive, we should welcome all means to increase our membership. By embracing online technology and allowing virtual meetings, New Hampshire State Granges will continue the tradition of being strong, vibrant organizations in our towns.

WHEREAS, Grange membership declined 40% between 1992 and 2007 and membership declines further, the Grange will continue to lose its relevance and influence in society. It is in the best interest of the New Hampshire State Grange to follow the example of many national organizations, as well as other State Granges, and make meetings accessible to all by allowing online meeting attendance.

WHEREAS, Grange traditions are a meaningful part of our organization, the intent of allowing virtual attendance is to enhance meetings, not to do away with our traditions. Our intent is to have members in attendance at the Grange Hall, with additional members attending virtually.

WHEREAS, older generations are tasked and eager to share their wisdom and experience but often lament having to attend meetings after dark, during inclement weather, or when they simply aren't physically comfortable leaving home which causes greater loneliness as their social gatherings diminish, New Hampshire State Grange has the ability to change this trend by allowing members to enjoy Grange meetings and traditions safely and confidently at home.

WHEREAS, the New Hampshire State Grange has always concerned itself with welcoming families into the organization and accommodating their needs fraternally, the Grange needs to continue to recognize the changing needs of today's families. Requiring that members may attend meetings only if they are able to be in the same room places undue restriction on members. Telecommuting has increased 115% from 2005 to 2015 and 24% of employed people did some or all of their work at home in 2015, the Grange needs to acknowledge the needs and habits of today's workforce and their expectations to be met on their own turf, literally.

WHEREAS, New England winters make travel treacherous, virtual meetings allow the good work of the Grange to continue as scheduled, despite the weather, while keeping members safe.

WHEREAS, adherence to an antiquated meeting rule by the New Hampshire State Grange is leaving Grange Halls deteriorating for lack of membership, the in-person meeting rule needs to adapt to an online presence, encouraging more to join the Grange. Doing so can have the same positive impact that Rural Free Delivery had on farmers lives in the late 1800's.

WHEREAS, denying Grangers to come together with current technology is akin to restricting lost pet poster placement to telephone poles. By embracing today's technology, the reach of the Grange is boundless. The National Grange has fought to ensure rural Americans have equal access to broadband services; it befits us to embrace the available technologies and use it to engage our communities.

WHEREAS, Grange meetings were once dynamic vibrant social gatherings that reflected and supported their communities. Today, according to the Pew Research Center, Internet use is part of peoples' daily routine. 7 in 10 Americans use social media to connect with one another. When the Center began tracking social media adoption in 2005, just 5% of American adults used at least one of these platforms. By 2011 that share had risen to half of all Americans, and today 69% of the public uses some type of social media. The New Hampshire State Grange needs to modify meeting requirements to meet the social needs of its members and can do this by allowing members to attend meetings virtually when necessary. And WHEREAS, fellowship is important for the New Hampshire State Grange to achieve its mission and goals, it needs to recognize social media as an important component to today's social gatherings of Grange meetings.

WHEREAS, the future of any organization lies with the children of its community, the New Hampshire State Grange will need to adjust its practices for a generation that no longer

remembers a time without computers. It's a generation that connects through emails instead of letters, has class time and completes homework online, and readily Skype and texts with grandparents. It behooves the Grange to not wait for this generation to age, but instead be proactive and make the change now.

THEREFORE BE IT RESLOVED, that the New Hampshire State Grange can once again claim pride of place in the forefront of our communities by embracing members whose circumstances require the Grange be more accommodating and allow them to attend their local official Grange meetings online, as members of the quorum, creating a meeting place accessible to all; to continue the good work and traditions of the New Hampshire State Grange.

Recommendation

This resolution is too long, more of a narrative or a story than a tightly written resolution. Considering these resolutions are actually incorporated into formal Grange record, the committee voted unanimously to not recommend this resolution.

NOTE: The Legislative Committee has repeatedly offered to assist Subordinate and Pomona Granges with the correct formatting and writing of their resolutions. We urge everyone to take advantage of this offer in the future.

Resolution #4 Submitted by: Centennial Grange #185 Subject: Election of Officers at National Grange

WHEREAS, the election of officers process is defined in National Grange Digest of Laws 10.4.1 as "ELECTIONS -- 10.4.1 Nominating speeches shall not be allowed in any of the Granges in the various divisions of the Order (Junior, Subordinate, Pomona, State or National) at the time of the election of officers; but in the election of officers, a member may present the name of another member as a candidate for a Grange office provided this rule has been adopted by the Grange having jurisdiction. A motion to close nominations is never in order and members may vote for a member whether the member's name has been placed in nomination or not." and,

WHEREAS, in all divisions of the order, except the National Grange, this process is followed by the numerous Granges across the country and have for as long as the organization has been in existence and,

WHEREAS, the delegates at National Session could spend this valuable time doing other important requirements assigned to them instead of guessing who they should suggest as the officers of the National Grange and,

WHEREAS, the election of Officers at National Session is traditionally conducted by secret ballot and counted by the Assistants and the Steward and,

WHEREAS, the National Session has now been shortened to cut down on expenses but still has the same amount of work to complete,

THEREFORE, BE IT RESOLVED, that the election of officers at National Grange be conducted in the same manner as prescribed in the Digest of Laws, and the National Master will open the floor for suggestions for the officers of the National Grange.

BE IT FURTHERRESOLVED, that this process be used for the 2019 election of officers at National Session.

Recommendation

The committee asked if the rules tell you to do something one way, why would you not do it that way? This is the case with the election of officers at National Grange, and we agree with the Centennial Grange that this process be changed to reflect the rules.

The resulting vote was unanimous in favor of the resolution.

Resolution #5 Submitted by: Hudson Grange #11 Subject: Annual Meeting of the New Hampshire State Grange

WHEREAS, the number of attendees at the Thursday opening of the Annual State Grange Session has declined in recent years and

WHEREAS, the business acted on during Thursday's session is general in nature and in most cases repeated during the opening of session the following morning

THEREFORE, BE IT RESOLVED, that Article V, section 1 of the NH State Grange Bylaws which reads "This Grange shall hold its annual meeting, between October 15 and the first <u>Thursday</u> of November, preferably <u>on the fourth Thursday</u> of October each year, convening at a time and place designated by the Executive Committee. be changed to read "This Grange shall hold its annual meeting on Friday and Saturday only, between October 15 and the first Friday of November, preferably <u>on the fourth Friday</u> of October each year, convening at a time and place designated by the Executive Committee.

BE IT FURTHER RESOLVED, that if passed, this will take effect at the 2019 Annual Session.

Recommendation:

This resolution would shorten the length of the State Grange Session, saving money for the Grange and its members. While this would mean not having the Fifth Degree at State Session, it was felt that this Degree is a job of the Pomona, ad not the State Grange.

The resulting vote in favor of this Resolution was unanimous

Resolution #6 Submitted by: Claremont Grange #9 Subject: Humane Treatment of Animals

Whereas the NH State Grange cares about the welfare of all animals in our state; and

Whereas there has been a noted increase in animal hoarding and cruelty cases in our state;

Therefore, be it resolved that the NH State Grange supports laws to address the mental health disorders relating to animal hoarding and cruelty.

Resolution #7 Submitted by: Claremont Grange #9 Subject: Livestock, Pet and Animal Seizure

Whereas the NH State Grange cares about the welfare of all animals in our state, especially Livestock and our beloved pets; and

Whereas the NH State Grange believes that all pet and livestock owners must be afforded due process of law; and

Whereas the NH State Grange believes that property rights must be protected according to law; and

Whereas the NH State Grange believes that seizure of animals should only be enforced as a last resort, and then only with advice of the State Veterinarian or a NH Licensed Veterinarian.

Therefore, be it resolved that the State Veterinarian or his/her designee be the sole decisionmaker in the seizure of livestock; and

Be it further resolved that local law enforcement officers be the decision-makers regarding seizure of small animals or pets, only with the advice of a licensed and practicing veterinarian; and

Be it further resolved that local law enforcement officers and/or licensed veterinarians are the only authorized investigators in cases of animal abuse and neglect; and

Be it further resolved that local law enforcement officers be required to use the manual for police officers published by the Governor's Commission on the Humane Treatment of Animals as their guide to identifying and dealing with animal cruelty; and

Be it further resolved that NH judges should always have discretion in the sentencing of citizens convicted of animal neglect, and that judges should take into consideration various options for animal seizure, including seizure in place; and

Be it further resolved that the cost of care for any seized animals must be reasonable and free of administrative costs.
