Thursday, October 25, 2012

Standing Rules of the 139th Annual Convention New Hampshire State Grange of the Order of Patrons of Husbandry

Ashworth by the Sea 295 Ocean Blvd Hampton Beach NH October 25-28, 2012

- 1. All persons, except special guests, shall be registered. Nametags and programs shall be issued.
- 2. Admission to the meetings shall be by nametag and password only. Upon giving proper password, the meeting Deputy will provide a colored sticker for the name badge to eliminate the need for giving the password again at this Session. If you are not wearing your nametag, you will be refused admittance.
- 3. As a common courtesy to all members, cell phones are to be turned off, or set on vibrate.
- 4. At least fifteen delegates shall constitute a quorum of the State Grange.
- 5. Every Subordinate and Pomona Grange in good standing shall be represented by the Master or his/her alternate and one other delegate from said Grange.
- 6. The voting body of the State Grange shall be all registered delegates.
- 7. Members attending as non-delegates may take part in discussion, with permission from the chair, but shall not make motions and shall not vote.
- 8. A member wishing to speak shall wait for recognition by the Master, and upon provision of a working microphone shall announce his/her name and Grange he/she is representing.
- 9. When two members rise to speak at the same time, the chair will first recognize the member seated the furthest distance from the Master's station.
- 10. No delegate shall speak more than two minutes on any question under discussion nor may speak a second time until all others who wish to speak have had the opportunity to do so.
- 11. All reports and other material for the permanent record, immediately on presentation, shall be given to the State Secretary, via a Scandisk which the State Secretary will provide and a paper copy of any report.
- 12. The rules contained in the current edition of <u>Robert's Rules of Order Newly Revised</u> shall govern the meeting in all cases where they are applicable and in which they are not inconsistent with the Bylaws and these Standing Rules.
- 13. These Standing Rules shall be presented to the members for adoption; a 2/3 vote shall be required for adoption.

THE AVERAGE AMERICAN SOLDIER

I cannot help myself from feeling pride and being proud for all our service personnel each time I read this. Just heard Secretary of Defense Rumsfeld say today, "Our troops are ready to go. We just need the word from the President," or words to that effect. The days ahead will bring a lot of hardship and death to many people on all sides. Only God can help them now, as it appears a war is written in the sand.

The average age of the Infantryman is 19 years.

He is a short haired, tight-muscled kid who, under normal circumstances is considered by society as half man, half boy. Not yet dry behind the ears, not old enough to buy a beer, but old enough to die for his country.

He never really cared much for work and he would rather wax his own car than wash his father's; but he has never collected unemployment either.

He's a recent High School graduate; he was probably an average student, pursued some form of sport activities, drives a ten year old jalopy, and has a steady girlfriend that either broke up with him when he left, or swears to be waiting when he returns from half a world away.

He listens to rock and roll or hip-hop or rap or jazz or swing and 155mm Howitzers.

He is 10 or 15 pounds lighter now than when he was at home because he is working or fighting from before dawn to well after dusk.

He has trouble spelling, thus letter writing is a pain for him, but he can field strip a rifle in 30 seconds and reassemble it in less time in the dark.

He can recite to you the nomenclature of a machine gun or grenade launcher and use either one effectively if he must.

He digs foxholes and latrines and can apply first aid like a professional.

He can march until he is told to stop or stop until he is told to march.

He obeys orders instantly and without hesitation, but he is not without spirit or individual dignity.

He is self-sufficient. He has two sets of fatigues: he washes one and wears the other. He keeps his canteens full and his feet dry.

He sometimes forgets to brush his teeth, but never to clean his rifle.

He can cook his own meals, mend his own clothes, and fix his own hurts. If you're thirsty, he'll share his water with you; if you are hungry, his food. He'll even split his ammunition with you in the midst of battle when you run low.

He has learned to use his hands like weapons and weapons like they were his hands. He can save your life - or take it, because that is his job.

He will often do twice the work of a civilian, draw half the pay and still find ironic humor in it all. He has seen more suffering and death then he should have in his short lifetime.

He has stood atop mountains of dead bodies, and helped to create them.

He has wept in public and in private, for friends who have fallen in combat and is unashamed.

He feels every note of the National Anthem vibrate through his body while at rigid attention, while tempering the burning desire to 'square-away' those around him who haven't bothered to stand, remove their hat, or even stop talking. In an odd twist, day in and day out, far from home, he defends their right to be disrespectful.

Just as did his Father, Grandfather, and Great-grandfather, he is paying the price for our freedom.

Beardless or not, he is not a boy.

He is the American Fighting Man that has kept this country free for over 200 years.

He has asked nothing in return, except our friendship and understanding.

Remember him, always, for he has earned our respect and admiration with his blood.

After the conclusion of the Memorial Service, State Treasurer Gail Turcotte was called upon to give her final report.

Treasurer's Annual Report

Worthy Master, Distinguished Guests, Associate State Officers, Members of the Pink Sash Family, Delegates, Brothers and Sisters:

I am pleased to bring you my fifth and final report as your State Treasurer. I will not be accepting the nomination for the office of Treasurer for another term. During the past five years we have traveled many roads and paths some of which I would never have guessed would need to be traveled. I will not miss the challenges of dealing with the Internal Revenue Service on a regular basis any more. As usual, I will not give you complete details of our finances now, as those will be printed in the Journal. These are some highlights of our past year that I would like to share with you.

Sherrill Bokousky and the members of her fundraising team have been very busy once again during the year and I would like to thank them for all their efforts. Fundraising remains an important goal for this administration but unfortunately we were not able to meet our goal of \$6,000 as set forth in the budget approved last year. Legal counsel for ongoing matters significantly increased that line item and we had to withdraw a total of \$14,000 from invested principal during the year to cover our operating expenses.

Anne and Marty Boisvert continue to manage our building in Hooksett and they perform as much maintenance work themselves as possible to help control costs. Our custodian Chris Heath keeps our building clean so it always looks inviting to anyone attending a meeting or function there. Thank you Anne, Marty and Chris for your efforts.

Our invested funds remain with Morgan Stanley and after our annual review with our financial advisor John Habig, Don Ross and I recommended to the Executive Committee that we continue with our present investment and spending policy. Our investment plan currently allocates 60 % to equities, 38% to fixed income and 2% to cash and equivalents with combined goals of growth and income.

We continue to carry the value of the State Grange Building at the purchase price of \$87,500.00. The former Contoocook Grange hall is still on the market with one interested party seeking a variance for use from the Town of Hopkinton.

Wicwas Lake Grange was able to pay off their remaining loan balance of \$835 in full this year. Thank you Wicwas Lake members for your diligence and hard work. This leaves our accounts receivable with a balance of \$345 owed by Halloween Grange for their loan.

A quick review of the special funds shows that the Grange Services Department used \$4000 income from the Education Loan Fund to award scholarships this year. The Randall Richardson Memorial Youth Fund continues to accept donations and income earned is used to aid qualifying members to attend National Session. This year four members are eligible to receive assistance with travel expenses to Boise, Idaho

We opened a new Defunct Grange account when the former White Mountain Grange treasury was transferred to us last fall. Following our financial advisors recommendation this money was invested in an I series US Treasury bond.

We just completed a twelve page compliance report to the IRS that dealt with our group non-profit tax exemption ruling. Reviewing, discussing and answering the 80 questions in the report reinforced the need for complete and accurate financial record keeping as well as remaining an active community service organization. I strongly encourage each Grange to review your records and be sure that you are keeping enough information to successfully prove that you are in compliance with IRS non-profit guidelines and rules. Our non-profit status is a privilege not a right and if we do not comply with current guidelines and continue to be active in our local communities any Grange could lose its non-profit status. Please keep this in mind when planning your Grange activities for the new-year.

All Granges in NH are still required to file an annual report to the IRS and most are able to file electronically by using the 990-N. For those few Granges that are unable to file on line I have paper copies of the 990-EZ form available here at my station or I will mail the form to any Grange upon request. The due date for either report is February 15, 2013.

I also want to take this opportunity to remind the Granges that own their own building and/or land that each year they must file for a real estate tax exemption with the city or town they are located in. Most towns use the state forms BTL A-9 and A-12 available on the NH Bureau Tax Land Appeal website but a few cities use their own forms. Either way it is the responsibility of the Grange as applicant to file the forms even if the town does not send you any type of notice. The actual deadline varies with each town but it is always due sometime in April.

We will be discussing the proposed budget Saturday morning and I would like to encourage each Delegate to take the time to review this proposal if you have not already done so. I strongly encourage fiscal responsibility- the NH State Grange is not so different from the average family- if you spend more money than you earn you will have to withdraw from your savings. Unfortunately withdrawing money from savings or in our case invested principal can only last just so long and then you run out of money and possibly endanger the financial future of our organization. In my opinion goals, dreams and needs should be balanced by keeping at least one foot grounded in reality and if the money isn't earned or raised you shouldn't plan on spending it by withdrawing principal. I will be glad to answer any questions about the proposed budget prior to Saturday morning session.

I would like to thank Don Ross and Beth Merrill, finance committee members for assisting me during this past year. Don continues to attend meetings with our financial advisor and he assisted me with the IRS compliance report and both Beth and Don offer advice whenever called upon. Thank you Worthy Master for being willing to listen to my suggestions. Even when Jim and I don't agree on an issue he is always willing to consider a different point of view before making his decision.

I would like to extend a large thank you also to Carolyn Ross, State Secretary for her assistance with our shared duties. Carolyn's diligence in mailing reminder notices of bills owed has helped keep our uncollected dues, bonding and assessment fees very low. I know it is never pleasant to be responsible for sending overdue notices to Grange friends. On a personal note without Carolyn's cheerful help Wayne and I would not have been able to travel during the past two years or enjoy his retirement each winter in Florida. We are looking forward to many more happy trips and warm winter days.

SECRETARY'S ANNUAL REPORT 2012

Worthy State Master, National Representatives Chris and Connie Johnston, Associate State Officers, Committee Members, Delegates and Patrons:

I will be presenting my final report as your State Secretary as I have chosen NOT TO seek another term as Secretary.

This past year Squam Lake Grange #258 closed on December 17, 2011 and a new Grange - Hinsdale #358 was charted on April 8, 2012. There are still more Granges out there that still need to consider on closing or consolidating with another Grange.

As of June 30, 2012 there are 11 Pomona Granges in the state with a total membership of 733, of which 213 are Golden Sheaf members. The largest Pomona is Merrimack County Pomona with 105 members.

As of June 30, 2012 we have 63 Subordinate Granges with a total membership of 1778, of which 427 are Golden Sheaf members. The largest Subordinate Grange is Wingold Grange with 69 members. The total membership number of 1778 that I reported does not include 20 charter members from Hinsdale as I did not receive any member's names and addresses until this past Sunday, October 21st.

By authority of the National Grange, I have issued the following membership awards:

When I became State Master in October of 2010, I believed at that time setting Goals was important. The error that I made in my judgment was that I set the wrong the Goals. The primary goal should have been growing the Grange here in New Hampshire! Not only creating new Granges but helping existing Granges with the revitalization process.

I submit the following proposals:

1.

I agree that it is nice to grow the State Grange invested funds, but what good does it do if we do not grow the Grange? It has

been nice and appreciated that members have been willing spend their own personal money to grow the Grange here in NH. We as an organization need to take financial responsibility if we are going to create new Granges and revitalize existing granges.

The delegate body of the New Hampshire State Grange create a Grange Growth Team that consists of the State Master, the State Membership Director and every Pomona Grange Master in the State.

The delegate body of the New Hampshire State Grange set a goal of creating at least one new Grange in each of the eleven Pomona Grange's by 2016.

The delegate body of the New Hampshire State Grange creates a financial incentive for each Pomona Grange to create new Granges, \$100.00 for the first Grange and \$150.00 for each additional Grange created in the individual Pomona's.

 The delegate body of the New Hampshire State Grange, encourage each Subordinate and Pomona Grange to sign a "compact of agreement" partnering with State Grange that Grange growth is a shared responsibility.

6. The delegate body New Hampshire State Grange promote the planning of two Rally Days, one in the southern part of the State and one in the Northern Part of the State. These are to be used as both as a membership tool so Grangers could bring potential members, and as an opportunity for Grange members to socialize and to re-connect and reignite the Grange spirit we need to move forward.

7. The delegate body of the New Hampshire State Grange creates a Social Committee, that will help Grange members rediscover the spirit of fraternity to rekindle our original mission of fellowship.

They took in 22 new members this year.

Subordinate Granges:

There are 63 Subordinate Granges in the state with membership from below the required 13 to 69 in 2 Granges. Since June 30, Wicwas Lake Grange has taken in 14 more, giving them 83. For the second year in a row Wicwas Lake is the top scoring Grange in the state.

The Deputies with some help, worked the first degree at the 2 degree days held this year, thank you to all who helped show our new members the beautiful lessons of our Grange ritual.

I conducted a workshop on the codebook at the Spring Fling.

Chris Heath has been working with Londonderry Grange, and they have taken in many new members. He has also been helping Friendship Grange as they start to grow.

Ida Hutchins continues to help at Wicwas Lake, and Matt Clark has been working with the new Hinsdale Grange.

That is this year, now, what to do in 2013 and beyond?

How many of you want your local Grange and the State Grange to be stronger and more active next year? In 5 years? In 10 years? This State Grange must change our thinking and place more emphasis and resources into membership development. We, as a State Grange should undergo a Visioning session, as many of our Subordinates have, to determine what we want the State Grange to be, where do we want it to go, and how to get there.

As to visioning, we have been scoring Granges the last two years, and will again in 2013. One addition to that will be any Grange, Pomona or Subordinate will receive 200 points for having a visioning or Growth Team come and work with them at a meeting. This team can be either from your Pomona, or contact Bob Trombi to have a state team come to your Grange.

Twenty of our Granges had a net gain in membership this year, congratulations to all of you. To have a net gain state wide, that number needs to double. Wouldn't it be great to be honored as a State Grange with a net gain the year we are hosting the National Grange session? This goal is within reach, we all must do our part to achieve it.

Some of our members have expressed a concern as to how we elect officers in the Subordinate and Pomona Granges. If you think you have a better way, write a resolution to attempt to change this most important part of Grange work, the choosing of our leaders.

The Deputy Force is always willing and able to assist Granges, to improve and strengthen them, and in turn the State Grange. Thank You, to the Deputies for your work this year, and I look forward to working with you in 2013 as we grow the Grange.

State Historian Report 2012

Worthy State Master, State Officers, Honored Guests, and Patrons all!

It is a pleasure to present my report as your State Historian.

I can't believe that 2011-2012 is almost history. I read and read some more and can't believe how much this organization continues to do year after year. I read the journals of past years and it is amazing just how much of an influence this organization had throughout the years.

I get very upset when someone says how the Grange used to do this or do that. People who are not members are left with the feeling that the Grange has ceased to exist. This is very wrong. The Grange may have changed in some ways of what they are doing in the Grange Hall or in the community but they are still very active. The farms in many communities have changed as well. While some are bigger than ever, there are some that have stayed the same. You will also find that more people today are doing some kind of agriculture whether it is a large vegetable farm, organic farming, Christmas tree farming. Maple sugar farming or traditional cattle or horse farming.

The members continue to write history without knowing it. It saddens me to see some Granges just going through the motions until they reach their 10th or 125th anniversary. Many think the Grange has no place in today's world. This is so wrong, so wrong. I would be so happy to assist a Grange write their history or even make contacts. The State Grange Journals provide so much history and important information when someone calls looking for their relatives or Granges in their community.

This has been a busy year for the State Historian receiving telephone calls from people asking for information about their relatives or Granges they were involved in. Marion Boardman was a Past Master of Cornish Grange and Sullivan County Pomona. She traveled throughout the area once broken her hip but she kept going. She will be missed in her area.

Genevieve Lounder served Ashuelot Grange as a Master and Matron for Ashuelot Juvenile Grange. She continued to serve the Grange as a member of Prentice Hill Grange.

Emilie Willard was a dedicated member of Miller Grange serving as Past Master for Miller Grange and Grand Monadnock Pomona. She and her late husband George Standley were always coming to State Grange Session. I can remember the first time I saw them. It was in Concord at the Highway Hotel.

George would stand and share his opinions. He would suggest his good friend Raymond Willard for a State Office. When George passed away, in a few years, Emile would marry Ray Willard and continued to travel throughout the area.

Janet McLean was another quiet member who served her Grange well. Her brother was Donald Ross, a member of our State Executive Committee. Janet was a member of Wingold Grange. She surprised a lot of members when she participated in the public speaking contest. Janet and her late husband David participated in the annual State Grange Bowling Tournament for many years. Janet will be missed by many who knew her.

Walter Sanborn was a member of Chichester Grange. I can remember the first time when I met Walter. I attended a meeting of Chichester Grange because I was serving as Junior Director and I was hoping to organize a junior grange. I could see Walt's expression and it scared me a little. However, the Grange voted to reorganize their junior grange. Walt loved the Fire Department. He also enjoyed his antique vehicle riding in parades etc.

Elizabeth Wright was a member of Hollis Grange and Hillsborough County Pomona Grange. She was a very quiet member but a very dedicated member.

Pauline Haines won't be mentioned here because her name somehow didn't transfer from Loudon Surprise Grange to Pineconia Grange. I received a call from a local funeral director who was handling the arrangements. It was mentioned she belonged to a Concord Grange but no name. I went back a found her name in Loudon Surprise and when they merged with Pineconia, somehow her name got lost. She felt she was a 65 year member of the Grange along being a Past Master of Loudon Surprise Grange and a Past Matron of Loudon Surprise Juvenile Grange.

Carryl Heath was a New Hampshire State Grange as Deputy. He and his late wife Natalie were members of New Durham Grange, Mountain Laurel Grange, Wattannick Grange, and Eastern New Hampshire Grange, serving as Past Master in some of them. Carryl was a dedicated Grange member as well as a loving family man. He encouraged his family to become involved and committed to whatever they took on. They were always willing to help a Grange. The first time I met Carryl was in 1969 when I was Youth Chairman for Pineconia Grange. This was my second year and it was in February, a snowstorm was hitting the state. So, we held our youth night and Carryl Heath and his family along with several friends brought a lot of enthusiasm to our meeting. Carryl went on to serve the Florida State Grange in later years.

Elizabeth Grant was a typical mother and grandmother. She belonged to Golden Rod Grange as well as Cheshire County Pomona. Elizabeth traveled many miles with her daughter Carolee Barrett when she was a Junior Deputy and then Junior Director. Elizabeth served on the State Contact Committee. She will be missed by many in her area. I can remember many times she would hold her granddaughter Alana when Carolee was busy doing something.

Kenneth Pelton was a guy who loved his Grange and served it well. Ken would come to many Grange Family Weekends with corn from his garden. He would give corn away to anyone who would enjoy a dozen or so. Ken served as Past Master for East Rockingham Pomona and Hampton Falls Granges. He served the State Grange as State Agriculture Chairman.

B. Franklin Hayes shocked many when it was learned he has passed away in Florida. He had moved to Florida with his wife Ginny. Frank was a friend to many regardless of age. He took a big interest in youth work, began the annual bowling tournament, served the State Grange by holding offices of Gatekeeper, Assistant Steward, Steward, Overseer and Master. He served briefly on the Executive Committee as well as National Grange Secretary. Frank was someone that you could go to talk about a Grange problem or a personal problem.

I can't tell you how shocked I was when Jerry Leclerc called me on Thursday and said Marylin Machia had

passed away. I was sick about this as I had just spoken to her about becoming a member of the Community Service Committee for next year. She said she would do serve and asked what district she would have. I told her and she was very happy to have been asked. She then asked about my family and how they were doing. We talked about the upcoming State Grange Session and she would be coming down with Jean Abbott. We then concluded our conversation. I met Marylin in 1980 when I became Junior Director and she would serve as a Junior Deputy covering the Northern Sector traveling to Groveton, Lebanon and Lower Intervale. She was a tremendous help to my late mother at Junior Grange Camp weekend. She enjoyed working with junior grangers and never complained about anything. She and Roy loved their family and traveled many miles in Grange work. She loved her cards and horseshoes at Family Weekend. Marylin will be missed by many people and I know she is with Roy and probably working on shoes as they owned and operated Roy's Shoe Shop in Littleton.

I finished the book I began writing three years ago, rewriting and rewriting. However I wanted to write a book that had a story to it, remembering funny moments, recalling games that were played at Youth Nights, and highlighted members that were so active played a major part in the State Grange. The theme will be "Thirty Years Showcasing Success and Innovation" since it will be the thirtieth year for the Expo. The NH State Grange has reserved a double booth space in conjunction with the Northeast Connection and will be letting people know about National Grange coming to NH next fall. Ideas are welcome.

Another outreach the membership committee discussed at Deputy School was having a greater presence at the State Fairs. Worthy Master, Honored Guests, State Officers, and Patrons:

I am pleased to give this report on the upcoming 147^{^m} National Grange Session to be held in Manchester, NH, November 12-16, 2013. We are excited to welcome the National Grange to our state for the first time since 1913 - yes, that's one hundred years ago!

National Grange conventions are held on a rotating basis among five regions around the country and hosting the national convention requires the combined efforts of the entire region. I will be serving as the

Region Coordinator, and Kerriann Nightingale Heath is our state coordinator and a member of the Host Committee.

The Host Committee met at the Radisson Hotel in April and had a tour of the facility. The entire session will be held at the hotel, including the Seventh Degree, which eliminates the expense of busing everyone to an offsite location. The Sixth Degree will be conferred by the NH State Grange, with some assistance from other states. The vast display area available to us offers possibilities for interesting and exciting exhibits about our region. We've decided to forego the Christmas Tree project that has become a tradition at recent national conventions and instead to set up a giant mitten, hat, and scarf tree. We're asking for donations of these handmade items from all members and at the end of session they will be divided among our seven states and delivered to schools and charitable agencies that are in need of warm clothing for their clients. Attention woodworkers! We are in need of a fabulous design for the framework of this "Mitten Tree".

At the April meeting, a team of four people was selected, which will travel to the convention in Boise next month to set up and staff a table to promote our convention and theme: "How Sweet It Is!" Kerriann and her newlywed husband, Chris Heath and Kathy Yardley will be sharing those duties as well as occasionally job shadowing the folks on the Western Region Host Committee.

We have also had a couple of Teamspeak meetings via the internet and expect these meetings to occur on a monthly basis very soon. We've had a bit of a problem getting everyone set up for this, but hope all those technical issues are behind us as we move forward with our plans. I and a couple of our Host Committee members have listened in on several of the monthly (10:00 p.m. eastern!) Western Region Teamspeak conferences and have gained some insight on plans we should be making and pitfalls to watch out for.

Each state has been assigned a day to provide volunteers for the registration table, the hospitality room, and deputies to stand at the gates during session. NH's day is Thursday. You can volunteer for one of these positions or you can help provide food items for the hospitality room. Gloria Davis and Diane Collins are the Hospitality Coordinators, so direct your offers and questions to them.

All seven states have been helping to raise funds to cover our regional expenses by selling T-shirts, polo shirts, and sweatshirts, water bottles and lunch totes, and glass ornaments. A number of folks in the NH State Grange have embraced the idea of "Grange Bucks" and have been collecting and turning in lots of one dollar bills with a "G" stamped on the left side of George Washington's picture. Thanks to all who have supported our fundraising efforts thus far, including the assessment contributions received by all seven State Granges.

Last year National Grange allowed us to temporarily use our maple tree convention logo selected in 2010 by the board of the Northeast Connection (comprised of Masters and Overseers of the seven states of the region) on souvenir items. This logo was designed by Kathy Yardley and was intended to accompany the winning theme suggestion "How Sweet It Is" entered by Hannah West. However, a new logo, designed by Connecticut State Grange's Terri Fassio, was approved last month by the National Master and is the new official logo from this point forward... So, our regional tree logo is being discontinued to allow the national office staff to design and sell their own version. Not having control over this logo has been a tough pill for many of us in the region to swallow, but in the end this IS the <u>National</u> Grange Convention, and the Washington staff should have the final choice in design. Shouldn't they?

There is a new batch of shirts available here at this session. Upon completion of our region's state conventions, we will pool the remainder of our T-shirts and sweatshirts to take to Boise next month to sell. After that, we will probably not place another order prior to the 2013 convention. If you've been meaning to purchase one of our logo items, now is the time! The polo shirts with the embroidered Grange emblem, however, may be continued even beyond the convention as they have been a big hit throughout the region. Unfortunately, the brand of polo shirt we were using for the last year has been discontinued, and the new brand of shirt does not offer the choice of so many colors as we have enjoyed until now. Did you know that you can special order a polo shirt in the size and color that you wish? Contact me for more details.

Our convention has a theme: "How Sweet it is!" There are plans in the works for ways to exemplify this theme to all our convention attendees, but the Host Committee will still welcome your ideas and suggestions as well. Here's what we're working on:

For Boise next month, we'll be offering complimentary bite size pieces of maple sugar to anyone that stops by our display table, where we will also be selling shirts and raffle tickets and providing brochures about Manchester and surrounding attractions. A NH FFA chapter is making the maple sugar pieces for us, but we can always use more if you have a contact that might be willing to provide them.

We'll also start selling tickets in Boise for our "How Sweet It Is" raffle. So far, we've acquired a custompainted sap bucket and two painted sap bucket lids to offer as prizes. We'll add more prizes throughout the coming year before we draw the winners at the national convention. Each of our seven regional states is being asked to provide a basket filled with "sweet" products made in that state. Raffle items can be any non-perishable sweet-to-eat treat and they can also be anything that exemplifies the sweet quality of life that we enjoy in the northeast region - especially items that are geared toward the harvest season.

A team of three of our region's youth members have created a promotional video that will be shown in Boise during the Celebration Banquet. I thank NH's own Sarah Leclerc for her assistance with this project. (The video was shown following this report)

Besides supporting our shirt sales and the raffle, there are other ways you can help with our hosting duties. One way is by submitting one or more entries in our Centerpiece and Table Favor Contest. Details for this contest are available at our display table, in the September 2012 issue of the Granite State Granger, and on the State Grange website and on our face book page, "2013 Convention NH". The entries will be judged at the January 2013 Northeast Leaders' Conference in Maine, so get your entries to me or Kerriann by January 1st if you are not planning to deliver your entry personally.

It's become customary to assemble goodie bags to hand out to each member when he/she registers during the convention. We'll be soliciting items from each state to put in these bags. Whenever possible, we're asking for 500 pieces of each item. Please keep in mind that many of our visiting Grangers are traveling by air, so we'll want to keep the items to a minimum in size and weight. For example, one year in recent memory, delegates and members were given jars of pickles, which many opted to leave behind in their hotel room, rather than risk them breaking in their luggage. Another consideration is our attempt to make this convention as "green" as possible, so we're asking that we keep brochures and other paper propaganda items to a minimum.

As you've now heard, there's a lot going on and plenty of ways that all members can assist the Northeast Region in hosting the most fabulous convention ever! I hope that we'll see many of you in Manchester, NH in November, 2013!

State Grange Building Report 2012

In last year's report I mentioned that our goal for this year was to get the basement under control and to spruce up the building and landscaping. The opportunity for the latter presented itself quite literally to us when a wind storm in March dropped a large spruce tree from the neighbors on the hillside onto the back driveway. Luckily the building received no damage. In April a chipper was rented and we managed to clear up the fallen tree and also removed the large tree that was overhanging the side parking area. We also played Tarzan and removed as much of the viney underbrush as we could pull and untangle from the larger trees. The same day, with the assistance of Mary West and Hannah West, the ceiling of the main room was painted to help hide the water spots and holes from tape being used in the past. Trying to do a painting project and tree work while entertaining a baby was a challenge, but we got it all done just in time for National Master Ed Lutrell's visit.

As for the basement, a committee met and cleaned out a lot of things that were being unnecessarily stored there such as expired canned goods and broken card tables. More needs to be done with regards to the historically significant documents stored there. The spare gavel blocks, implement cases, and staves need to be sorted and inventoried, but progress has begun.

One of the cupboards from the storage room formerly used by the Pansy Rebekah Lodge was moved to the women's bathroom to store supplies that belong to the Gun Club for their monthly dinners before meetings. The rest of the storage room is in transition. The lock on the door has been changed, but the room has not yet been re-appropriated.

Regular maintenance of the building continues as usual. The assembly permit was again renewed with the Town of Hooksett. After the replacement of one smoke detector, we passed the inspection without incident. Orkin Pest Control continues to check in on the building after an issue with carpenter ants a couple of years ago. Chris Heath has been doing summer lawn maintenance and cleaning the building. The furnace was cleaned this fall and the fire extinguishers will be inspected in a few weeks. The technician who cleaned the furnace seemed more concerned than in past years with the rust on the legs of the oil tank and recommended it be reinforced. We built a staging underneath the tank so that even if all the legs should give out at once, it won't fall more than half an inch. The tank was also sprayed with rust reformer to stave off future problems.

Hannah West has continued with taking reservations for the use of the building and arranging for the pickup and drop-off of keys. Several groups have used the building for baby showers, birthday parties, and other such gatherings. Local Granges, the Gun Club, the NH State Grange Executive Committee, and the 2013 National Grange Hosting Committee have all been meeting at the building. Many other events such as the National Master's presentation and the Lecturer's Variety Show were held there.

Goals for the coming year include continued work on the basement, landscaping, and further beautification of the building in preparation for any visitors to National Session 2013 who may wish to check out our building. We are also in search of someone who would like to take on the responsibility of care of the gardens.

These are available to Grange members in New Hampshire who have belonged to a Grange for at least one year. This scholarship/grant does not need to be repaid. The amount of available funds depends on the interest earned from our invested funds. The following members were awarded a scholarship at our annually meeting. Casey Doig, Robert C. Varnum and Hillary Ward. The State Grange wishes them well as they continue their education.

National Grange Benefits

Many benefits are available to you from the National Grange, just because you belong to a Subordinate Grange. To mention some there are, Travel Center, Choice Hotels, American Income Life, Life Line Screening, US Pharmacy Card (Scrip), RX Pharmacy CVS Caremark, Hertz Rental, Med Air Services also Beltone Hearing Aid, True Hearing and a Prescription Drug Coverage. Plus Wire fly – cell phone services, VIP Pet Insurance and LTC Financial Partners. State Session Coordinator 2011-2012

Worthy Master, National Representatives, State Officers, Delegates, Brothers and Sisters All:

Last year it was a pleasure to work with the Town & Country Motor Inn. Having the convention end with a snowstorm was not my way of thinking. Many of our Grangers went home to a lot of snow or even no power.

Here we are back at the Ashworth by the Sea. I did not expect that we would be back here so soon. As usual I called a couple of hotels to find out that they where booked already. One day I was talking to my sister Carolyn Ross and she said call the Ashworth and I did.

The Ashworth by the Sea turned 100 years old this past May. You will also notice since our last convention the Breakers and main dining room have been remodeled. You also may have noticed the new look to the

beach front. Over \$14,500,000 has been spent to make the much needed improvements. Along with the improvements comes the higher parking fee at the state owned parking spaces.

I found out that the hotel did not have a wedding or a group booked for this weekend. I then asked for a contract. I found out that the prices of the rooms had gone way up. I then prepared a letter and sent it to the hotel. I asked that the prices be changed and to my amazement they where changed for our group. This is the second time that I have renegotiated the price of the rooms. The first time was at the Best Western Sovereign in Keene.

As it turns out the hotel is very full this weekend. The hotel cut off my group contract three weeks ago. Now a three-night stay is \$585.00 and a Saturday night stay is \$216.00. Now you can see that the rates that I was able to acquire are very good.

Back in 2010 I had called the Holiday Inn in Concord. At that time the meeting rooms and restaurant where controlled by an outside company. As it turns out you had to rent the convention space. As we require a meeting room and display room we would have had to pay about \$1,000 for the three-day convention. Last year at State Grange Dick Patten asked me why we couldn't hold the convention at the Holiday Inn. in Concord. He told me that the policies of the hotel had changed. Thanks to Dick Patton we will be back in Concord next year.

The last time we visited the Holiday Inn was back in 1994. That was the year Dick Patten was installed as Master of the NH State Grange. Back in 1994 our convention was really too large to be meeting at the Holiday Inn. Now that we have fewer Subordinate and Pomona Granges it will work out very well.

The hotel rates will be \$99.00 plus tax. As it turns out the rates are just about the same as they are here at the Ashworth. The only difference the Ashworth charged \$108.00 and the state tax is included.

The Holiday Inn is on a national reservation system. Our block of rooms will be cut off on October 2, 2013. Then the room rates will go up just like they have here at the Ashworth.

I would also like to thank the delegates at last year's convention for passing Resolution #2. I will be starting in the next few months looking for the location for the 2014 convention sight. I will now be able to make a hotel reservation for the 3^{rd} weekend in October if I should need too. As I stated last year I will not book a hotel for the 1^{st} weekend in November as many of our Grangers attend the National Session.

I will continue to send out hotel and banquet information twice a year. With the cooperation a new State Secretary, this information will continue to be included with the quarterly reports. All State Grange Convention information will also included on the State Grange website and in the GSG.

This year is the 4th year that I have been in the position of the NH State Grange Session Coordinator. Every year I try to fine-tune the rooming lists. This year I found out that two weeks prior to the deadline my rooms count list was still very low. I was surprised at the people that should be on the list had not even registered with the hotel. Then shortly after that discovery an e-mail was sent out.

I am also very surprised about the counts at this year's banquet. There is a 45% increase in the counts. The payment method and due dates are going to be looked at this winters directors meeting. This year there have been way too many banquet requests with no money to back up the reservations. I do not want to resort to the method that they have at the Massachusetts State Grange. They are required to make out a form with a check enclosed and send it to the State Grange Steward. I personally do not want to have to use this method.

In closing this has been another interesting year. I am already looking forward to the next directors meeting.

Report of the Master's Address Committee

Worthy State Master, Delegates, National Representatives Chris and Connie Johnston and Brother and Sister Patrons,

The committee joins the State Master in applauding the successes of the Wicwas Lake Grange, Londonderry Grange, and the organization of the new Hinsdale Grange. However, the committee could not agree more strongly with the State Master that the Grange needs to be strengthened, and our Grange spirit reignited. To that end, we have the following suggestions to the Master's proposals

Proposals

Number 1 – Create a Grange Growth Fund. The committee agrees that we should commit **\$15,000 from** the former Claremont Grange escrow account, now in the investment account, to establish a Grange Growth Fund. The Grange Growth Team will establish policies and procedures by the expenditure of these funds with the approval of the State Executive Committee.

The delegates accepted the committee's recommendation as amended.

Number 2 – The concept of a Grange Growth Team is accepted, but we suggest that the membership include the Organizing Deputy and Membership Director, who work together with an appointed, willing and enthusiastic committee

The delegates accepted the committee's recommendation.

Number 3 – The committee feels adding one new Grange in every Pomona by 2016 may not be the best course of action for every Pomona. It **shall be the goal to either add a new Grange to each of the Pomona's,** or revitalize an existing Grange with an equivalent amount of members.

The delegates accepted the committee's recommendation as amended above in bold.

Number 4 – Creating a financial incentive for each Pomona Grange to create a new Grange. The committee feels that this money is better put to use someplace else. The recognition of the announcement at State Grange should be sufficient recognition.

The delegates accepted the committee's recommendation.

Number 5 – Compact of Agreement that growth between the Subordinate and Pomona Grange is a shared responsibility. The committee understands and agrees with the concept, but without some contractual incentive or disincentive, it seems ineffective.

The delegates accepted the committee's recommendation.

Number 6 and Number 7 – Proposal 6 to promote the planning of Rally Days and Proposal 7 for creating a social committee should be combined. We feel there should be a Social Committee that will promote events that people will want to attend, with a minimum of at least two Rally Days. The committee should be made up of young people, families and older Grangers so that all are taken into consideration in the proactive planning of events, as well as participation in existing community events around the state.

It was brought to the delegates' attention that the creation of the Social Committee was under the direction of the Master.

The committee joins the Master in recognizing and thanking those stepping down for their service and dedication, and wish them well. The committee also expresses their condolences to the families and friends of those Grangers who have passed during this year.

The committee would like to express our thanks to the State Master for the privilege and honor of serving on this committee.

Wayne Turcotte was called upon to give the report of the Resolutions Committee. Resolution #1 - Submitted by: Cheshire County Pomona #6 Subject: Pomona and Subordinate Granges entering into contracts

WHEREAS, in these times of high expenses, a Pomona Grange or a Subordinate Grange may need to enter into a contract for services provided by outside contractors or businesses, and;

WHEREAS, a second set of eyes can help to scrutinize a contract for potential problems for the Pomona or Subordinate Grange, therefore be it;

RESOLVED, that prior to a Pomona or Subordinate Grange entering into a contract that could result in a large debt, (greater than \$5000.00) that the Pomona or Subordinate Grange must contact their State Grange Master and Executive Committee in writing, with the details of the proposed contract and/or circumstances, to request permission to enter into said contract, with the exception of emergency work required due to a natural disaster or similar circumstances, and be it further;

RESOLVED that the following section be added to the National Digest:

4.11.6 Entrance into a contract by Subordinate or Pomona Granges – No Pomona or Subordinate Grange may enter into a contract that could result in a large debt, (greater than \$5000.00) except upon the following conditions:

(A) A written notice shall be sent to the Master and Executive Committee of the State Grange having jurisdiction advising of the intent to invoke the procedure included in Article XI of these By-Laws to enter into a contract. Such notice shall contain a summary of the reasons for the proposed contract and a copy of said proposed contract.

(**B**) The State Grange Master and Executive Committee shall review the proposed contract for protection of the interests of the members and the Grange organization and shall approve, vote down or submit recommended changes to the proposed contract, in writing, to the Subordinate or Pomona Grange within 10 calendar days. If the proposed contract was voted down, the State Grange Master and State Grange Executive Committee must list their reasons for voting down the proposed contract in their written response. If changes to the proposed contract were made by the State Grange Master and State Grange Executive Committee, the Subordinate or Pomona Grange shall negotiate the proposed changes with their contractor and re-submit a new proposed contract in accordance with (A) above.

(C) Any resolution adopted by a Subordinate or Pomona Grange for entering into a contract, is inoperative unless consented to, in writing, by the Master and Executive Committee of the State Grange having jurisdiction over the said Subordinate or Pomona Grange. Such consent shall be given only if the conditions of such contract are to be used for the benefit of present and future members of the said Subordinate and Pomona Granges as a fraternal group for Grange purposes. Such uses may include the repair, expansion or improvements of an existing Grange Hall or other Grange real property and the acquisition of fixtures, furniture, equipment or other furnishings for such Grange real property or for resolving litigation, or for use in accordance with the general purposes of the Order.

(**D**) If the Master and Executive Committee of the State Grange consent to the contract, then in that event the procedures for notice, resolution, meeting and vote contained in Sections 4.11.1 (B) through (F) of these By-Laws shall be applicable except that such procedures shall be applicable to entering into a contract, rather than sale of real property.

(E) These requirements may be waived and/or modified by the Master and/or Executive Committee of the State Grange having jurisdiction, through telephone conversations or other electronic media, in emergency situations where there is a need to act quickly either to save/preserve the value of property, after a natural disaster or fire or there is a requirement to make expenditures that are mandated via a government agency.ie a special assessment or in cases where the Grange does not have much choice but to spend money as required by circumstance or fiat. This emergency expenditure is not to exceed \$25,000.00 without following the full requirements of section 4.11.6 of this Digest of Laws.

Resolution Committee recommends adoption of this resolution. The delegate body adopted this resolution.

Resolution #2 - Submitted by: Cheshire County Pomona #6 Subject: Campaign Finance Reform

Whereas, The Grange in its long history has been an advocate for clean and fair elections; and

Whereas, Whether you are a Republican, Democrat or undeclared voter, knowing the sources of candidates campaign finances is only good public policy; and

Whereas, Outside groups can spend millions of dollars on messages and to defeat individual candidates and have their donors remain anonymous; therefore be it

Resolved, That the New Hampshire State Grange and the National Grange advocate for a constitutional amendment that would overturn the "Citizens United case" that classified corporations union and outside special interest group with the same free speech rights that are enjoyed by everyday citizens and exempted them from campaign disclosure laws and restore transparency campaigns and election funding.

Resolution Committee has no recommendation. The delegate body took no action on this resolution and the resolution is considered defeated.

Resolution #3 – Submitted by: Northern New Hampshire Pomona #5 Subject: Closed Rest Areas in Northern New Hampshire

Whereas, Northern NH relies heavily on tourism as a source of revenue, and hosts tourists from all over the world; and

Whereas, long-haul truckers are required by Federal law to rest periodically to maintain their licenses; and

Whereas, Northern NH, in particular, is an economically depressed area; and

Whereas, the Rest Areas have been a boon to tourism and a convenience for long-haul truckers; and

Whereas: the closure of the Rest Areas sends a mixed message to tourists and truckers ("Welcome to NH—We're closed"); and

Whereas: the closing of the Rest Areas lead to trash along the highways, a sanitation problem and a safety hazard as truckers park along the highways and at turnouts that are not long enough for them; therefore be it

Resolved: that the NH State Grange support the re-opening of the Rest Areas in <u>Northern</u> NH on a fulltime basis; and be it further **Resolved**: that the NH State Grange go on record as supporting the renovation and upkeep of these buildings and grounds *and advocate removal of barriers to allow travelers to utilize the parking lots for rest breaks*.

Resolution Committee recommends adoption and thinks that it should not be limited to Northern New Hampshire and advocate removal of barriers to allow travelers to utilize the parking lots for rest breaks. This resolution was adopted as amended by the delegate body

Resolution #4 – Submitted by Concord Grange # 322 Subject: NH Humanities Council Presentations

Whereas, the program presented by the NH humanities Council regarding the History of the Grange in New Hampshire to 1955; and

Whereas, people attending this presentation might come to the conclusion the Grange is no longer in existence and thereby hurting chances of possibility of gaining a new member; therefore be it

Resolved, The State Master along with two other members to be appointed by him to meet with the NH Humanities Council in an effort to stress the importance of focusing on the positive image of Today's Grange and not focusing the demise of the Grange in the 1950's; and be it further

Resolved, a meeting should be scheduled as soon after National Grange has completed its current session.

Resolution Committee does not recommend adoption. This resolution was defeated by the delegate body.

Resolution #5 - Submitted by Concord Grange # 322 Subject: Northeast Grange Events

Whereas, the six New England States plus the State of New York hold the following events annually such as Northeast Youth Rally, Northeast Lecturer's Conference, Go To Church Sunday, and Northeast Leaders Meeting; and

Whereas, the attendance at these events has continued to decrease due to costs of traveling, age of members or members having difficulty in getting vacation time from their employers to attend during the weekdays; therefore be it

Resolved we are requesting the Leaders in charge of these events meet and discuss the possibility of scheduling these events at the same time preferably during a weekend from Wednesday to Sunday or Thursday to Sunday in which the Youth Rally, Lecturer's Conference, and Go To Church would be held. This would enable everyone attending being able to support each these events. The exception would be the Northeast Leaders Conference which is held in December or January and the planning for the upcoming meeting would be held; and be it further

Resolved, the States would continue to rotate each year as currently but possibly holding them at a hotel or conference center and if found practicable, be scheduled by 2014.

Resolution Committee has no recommendation. This resolution was adopted by the delegate body.

Resolution #6 - Submitted by: Hillsborough County Pomona #1 Subject: United Nations Convention on the Law of the Sea (UNCLOS)

Whereas, from 1958 - 1994, the United States was a leader among nations in the development of rules which define a country's rights, duties, and outer boundaries of territorial waters, fisheries, and the ocean floor; governance of marine environment and scientific research; and management of seabed minerals; and

Whereas, a review of the United Nations Convention on the Law of the Sea (UNCLOS) by the Reagan administration in 1981 found six criteria related to deep seabed minerals to be unacceptable to the United States, which have since been successfully addressed in the Agreement Relating to the Implementation of Part XI of UNCLOS; and

Whereas, the Convention and Agreement were signed by President Bill Clinton in 1994 and have since received strong support from every President and Cabinet, all of the Navy and Coast Guard leadership, heads of shipping, energy, fishing and telecommunications industries, and the environment and conservation community; and

Whereas, UNCLOS must be ratified by the United States Senate in order for the United States to be a full partner with the countries within the United Nations who have adopted this Convention; and

Whereas, the U.S. Senate, due to partisan politics and other business deemed more pressing than the oceans, has prevented the Convention and Agreement from being debated by the full Senate; therefore be it

Resolved, that the National Grange encourage action and debate by the U.S. Senate to ratify UNCLOS, and thus adhere the United States to the same oceanic standards and regulations as more than 160 other nations have already adopted.

Resolution Committee has no recommendation. This resolution was adopted by the delegate body.

Resolution #7 Submitted by: The New Hampshire State Grange Executive Committee Subject: Interim Legislative Policy Authorization

Whereas, the Delegate Body of the New Hampshire State Grange has the responsibility of determining policy for the purposes of advocacy; and

Whereas, many important legislative issues that require immediate response, arise during the year between the annual State Grange sessions; therefore be it

Resolved, that the Delegate Body of the New Hampshire State Grange authorize the NH State Grange Executive Committee <u>in conjunction with the Legislative Committee</u> to set interim legislative policy between state sessions. The Delegate Body <u>shall</u> determine whether to make the policy permanent at the next annual session through the resolution process.

Resolution Committee recommends including the Legislative Committee to assist the Executive Committee in setting interim legislative policy. The delegate body adopted this resolution as amended.

Resolution #8 - Submitted by: Cheshire County Pomona #6 Subject: Political campaign signs

Whereas, political camps put out signs for their candidates along the road side; and

Whereas, those signs pose a safety hazard to motorists; and

Whereas, many of these signs are in the way of DOT operations along the roadside; and

Whereas, some people who place these signs are going to the extreme and placing multiple signs within a short distance, many times a few feet apart; therefore be it

Resolved, that the New Hampshire State Grange go on record in support of legislation to restrict the number of campaign signs in one area to be no more than <u>six</u> signs per candidate in one half mile stretch of road, <u>not to include private property</u>.

Resolution Committee recommends adoption. The delegate body adopted this resolution as amended.
