### **Legislative and Agriculture Department Annual Report**

Worthy Master, National Representative, Officers, Directors, Delegates and Grangers all.

This is my sixth report to you as your Legislative and Agriculture Director. For all of the years I have been the State Grange Legislative and Agriculture Director, I have also been a State Rep. Well this year I lost my primary and after December 6 I will no longer be a Rep. I might add the Sister Tara Sad, a fellow Rep and a member of the State Grange Legislative and Agriculture Committee has left (retired) from the Legislature too. There are very few Grangers left in the NH Legislature in Concord.

As your Legislative Director I continue to serve across a broad range of Agriculture and Agriculture related organizations. I am not only a member of the NH Farm Bureau, but also represent the NH State Grange on the Farm Bureau's Government Affairs committee. One of the goals I had as the Director was to move the Grange and Farm Bureau closer together. I have also

now been elected to the board of the Hillsborough County Farm Bureau, where I will continue the message of Grange to the local Farm Bureau. I also have a membership in the New England Farmers' Union. I, along with Rep. Sad have for a number of years also been judges for the State FFA Convention and even went to the National Convention a year ago as judges. Last year we started judging 4H. We have both been active in State Agriculture and Rural Leaders as well.

The Worthy Master has decided to Split Agriculture off from Legislative for the next two years. I will keep Legislative and will work hard to do the job. I do intend to stay on as the Grange Representative to the Farm Bureau Government Affairs Committee.

This past year we participated in Deputy School, We hosted Grange Day at the State House, which did not work so well this year. We are no longer allowed to have lunch served in Committee Rooms. That is a result of too many spilled drinks on relatively new carpet. We did have our legislative panel at Spring Fling with only Dick Patten, Tara Sad and yours truly there to represent Grangers in the legislature. It is even going to be tougher getting folks now with two less Grangers that are also legislators.

We did have a very successful Legislative Fly In here in NH for the First in the Nation Presidential Primary. The attendance was good and the feedback from participants was very positive. I hope someone will pick that up in four years. Grange Day at the Big-E took place and a few from NH participated, including our Worthy Master. I will call on all Legislative Chairs from all Subordinates and Pomona Granges to attend the Big E next Grange Day, visit the Critters in the livestock barn, tour the NH Building and visit the New England Grange Building, Then stay for the Parade.

During the coming year, I will forward important legislative information to all of you and from time to time, ask you to call yours Reps to lobby the occasional bill. I will also once again offer help with Resolutions. If you tell me what you want a resolution to say. I am only too happy to help format it.

Last year we presented the Legislator of the Year Award to Representative Robert Theberge of Berlin. At the Awards Banquet this year we will give the award to Rep. Shawn Jasper, Speaker of the NH House for his outstanding management, under very difficult circumstances, of the House of Representatives and his fair treatment of all Representatives.

Worthy Master, National Reps, Delegate Body, Brothers and Sisters,

I make this report on behalf of the New Hampshire Trustees to the New England Grange Building Master Christopher Heath, Overseer Robert Trombi and myself.

This year we had 3 meetings leading up to the Big E. Our first was Leaders Conference where Master Christopher Heath was re-elected secretary. Brother Leroy Watson was on hand to discuss Grange Trademark and the National Grange. Another topic discussed was handicap accessibility to the New England Grange Building. At present time, the New England Grange building is not handicap accessible. This does limit some patrons from entering the store and viewing our hall.

April Meeting Brother Noel Miller from Connecticut reported his findings. Pending permission from the Big E, a ramp could be placed on the side of the building. He also reported there would be no feasible way to provide handicap access to the lower level (Yankee Candle Store). Some of this year projects included:

- Painting basement Floor
- Repairs to the floor in the ladies bathroom
- Painting of the columns in front of the building
- Adding a cage to protect the needlework on display

Gates have also been added to the doors of each state room. The upstairs have been subject to some slight vandalism and disorder. Doors may be unlocked if a member of that state is present and can remain there during the time it is open.

In the Grange Store Sales included:  
Jellies and Jams approximately \$11,500  
And handicrafts approximately \$14,000  
Bringing total receipts to \$25,661.26

State Treasurer Daniel Bascom was called upon to give his annual report.

Worthy Sate Master Chris Heath, National Reps. Chris & Duane Hamp, Fellow Officers, Grangers All:

What a year this has been, Kim and I hosted the Bascom Family Reunion (held once every 3 years) in July over 160 attended. My work schedule was off the wall, I normally install about 8 irrigation systems a year, I have installed over 30 this year. Somewhere in between all this I found time to deliver over 75 cords of wood and kept the State Grange bills paid and accounts up to date.

The biggest challenge I have found for all Grange's this year is filing the e postcard. Those of you who filed by Feb. 15<sup>th</sup> had no problem. Anyone filing late after March have had many headaches. Sometime in March the IRS changed their web site. You now have to set up an individual account and many have had difficulty doing this. I have set up an account as a preparer and can file for any Grange in the State. To date I have filed for 15 Grange's and am happy to file for any Grange that needs help. I would rather file for you than to have to help you reinstate your non-profit status as this requires a lot of paper work and costs over \$400.00. As of October 1<sup>st</sup> it is now time to file last year's e postcard, the IRS gives you until February 15, 2017 to get this done. As I stated above if you filed by February you will have to set up a new account or ask me to file for you. As your State Treasurer I am providing this service as another benefit from you State Grange.

Last year I voiced my concern on the downslide of our financial investments, I am happy to report the investments have rebounded. To those Grange's with escrow accounts, I work with a 3 year average, so even in a down year your checks would most likely increase as they did this past year.

The Executive Committee continues to monitor our financial status and tries very hard to keep our expenses down. For 3 years now we have not and I repeat have not had to withdraw anything from principal and this is all due to the Executive Committee's due diligence. Marty and Anne Boisvert have worked very diligently to keep our State Grange Building functioning. They have provided the Executive Committee with a wish list of items that need repairing, replacing or updating. With this in mind we only received \$10.00 in State Grange Building donations this past year. Some of these items can be very expensive and may raise havoc with the budget, any donations would be greatly appreciated.

I will not bore you with the details of our financial status at this time as all accounts will be printed in the Journal.

We continue to carry the value of the State Grange Building at the purchase price of \$87,500.00. As I become more familiar with this office I am finding better ways of doing things and was able to get a reduction in the accountant's costs due to the paperwork I sent her. Morgan Stanley continues to work very well for us and is readily available to do any changes I need done. I also deal with Edward Jones financial advisors and find both Morgan Stanley and Edward Jones very comparable in their investments.

I want to thank each and every one of you for your confidence in me, this is a very challenging job and I enjoy the challenges set before me.

State Secretary's Report  
Worthy State Master, National Representatives, Delegates, Brothers and Sisters

This is my fourth report to you as your State Secretary.

Subordinate Granges:

We began the year with 61 Subordinate Granges; Grafton Star # consolidated with Park Grange # , Friendship Grange #110 consolidated with Harmony Grange #99, Mont Calm Grange #70 consolidated with Blow-Me-Down Grange #234, Hooksett Grange #148, consolidated with Pembroke Grange #111, Peterborough Grange #35 and Somersworth Grange #264 closed all effective December 31, 2015. Leaving us with a total of 55 Subordinate Granges. With a total membership of 1462 a loss of 101.

The Subordinate Grange with the largest number of members continues to be Wicwas Lake #292 with a total of 86 members

Pomona Granges:

We began the year with 11 Pomona Granges. Carroll County Pomona was closed in November 2015, Upper Coos Pomona #14 was consolidated with Northern NH Pomona #5 effective June 30, 2016. Merrimack County Pomona #3 was closed effective June 30, 2016. The subordinated from Merrimack County Pomona #3 were redistricted to Suncook valley Pomona #12 and Pemigewasset Valley Pomona #18. Leaving us with 9 Pomona Granges.

The Pomona with the largest numbers of members is Merrimack County Pomona #3 with 97 members.

It is important to note that most of the members from these affected Pomona and Subordinate Granges have sought membership in the consolidated or another grange. Unfortunately there are other Granges that are currently looking for assistance in closing or consolidation. Let me assure you that every effort is being taken to insure that the affected members are not lost.

It was announced in my report to you last year that the Roster would have a new look for 2016. I am happy to report that this became a reality and was able to have the Roster ready for Deputy School in December. I have received many positive comments on the new format. Most like the new size and the way that it is set up. Of course I couldn't please everyone and for that I'm sorry. This new format did enable me to print the roster on fewer pages than the previous one. Now that this has been accomplished creating the 2017 roster will hopefully go smoother.

As with any document there needed to be some corrections and updates. Roster corrections were sent to the granges and hopefully made it to the Masters and Secretary's copies. I am asking all secretaries who have not yet sent in the new form for the coming year to please make sure that this form is filled out clearly. Most of the corrections that needed to be made were because the information was difficult to read. For those who have sent the form already, thank you. If something is not clear you will be receiving a call from me.

The Journal of Proceedings for the 142<sup>nd</sup> Annual State Grange Session was completed and ready for distribution at Deputy School. This document is the history of the activities and results of the action taken at the session and remains a priority to me to have it completed as soon as possible

so that those wishing a copy can receive one while the session is still fresh in their minds. I'm a little disappointed that only two requests were made from Granges for a copy of the journal and only 3 individual members requested one. I do hope that many did take the time to review the journal on the NH State Grange web site.

Near the end of each quarter a packet was sent to each Pomona and Subordinate secretary with information for the members as well as the usual report forms. I can't stress enough how important it is to complete the reports and send them in on time. What we pay to National Grange is based on the membership numbers from these reports. If I don't receive a report from a Grange the membership number I use on my report is the number last reported. There have been times when a Grange report was submitted after my deadline to National and the Grange reports a loss of members. If these reports were sent in on time we wouldn't have needed to pay dues on the lost members now being reported. I also need to stress that it is extremely important that the dues check accompany the report. Several granges are sending these separately which requires unnecessary documentation.

The Subordinate Grange Quarterly Report form had changes made this past year. One change was the membership dues to State Grange increased effective January 1, 2016. The other change was the addition of Junior Grange members to the Subordinate Grange report form. With the new membership options for Junior's, it was felt that the best way to track junior membership was to include them on the Subordinate report from which they are sponsored. This is still a work in progress and some changes may still need to be made.

As the Secretary it is our duty to keep our members informed and this is done with the reading of communications. I have been to meetings where the Secretary reports that they received a letter, minutes of the State Executive Committee, or the announcement of an event and said I have it hear if anyone wants to read it. This practice needs to stop, often times as a State Leader we are asked by members who didn't know about an event or something that they felt they should have been told. Only to find out that their secretary didn't read it at a meeting. I would like each Subordinate and Pomona Secretary and committee chairman to establish the following philosophy, if it's mailed to you for your Grange, read it out loud to your members. The communication doesn't need to be read word for word giving highlights is fine as long as the important information is shared.

The supply department continues to be very busy filling orders. This is one area that I have struggled with this past year. One issue I had was changes in staff at National Grange created issues with receiving supplies and awards in a timely fashion. This has since been resolved with the addition of Monroe Classic as the new supplier of Grange supplies. Another issue is the receiving of membership award and supply requests on scrap pieces of paper or in an e-mail. In the future any membership award needs to be submitted on the appropriate form provide for the year recognition. An incomplete form or scrap piece of paper will now be returned to the Secretary along with the appropriate form. As for Grange supplies, I will be developing an order form and will make it available to all secretaries. All membership award forms and supply order form will be placed on the Grange website once they are completed.

This past September, State Master Chris Heath and I held 4 area meetings for Masters and Secretaries. The purpose of this was to provide them with the tools needed to be successful in the performance of their duties. Each was issued a copy of the National Grange Digest of Laws and the NH State Grange By-laws. Master's received a code book and Secretaries received the order forms for the membership awards and a list of members belonging to their Grange. The secretaries were reminded of their duties, reviewed the changes made to the report form and the new procedure for the ordering of the membership awards and supplies. For the secretaries who were unable to attend one of the area meetings, I will be sending the procedure for placing orders.

I need to apologize to the Secretaries in the northern part of the state. I was unfortunately unable to attend the area meeting at Mohawk Grange. I started a new job in September and was required to work that day. If any of you would like to take some time during this session to meet with me please let me know and arrangements will be made.

State Session is once again approaching and with that comes the preparations associated with it. The program was created, printed, and folded, resolutions formatted, printed and collated, ribbons ordered, delegate packets assembled the list goes on and on. I must admit that while this seems to be overwhelming I find it exhilarating and look forward to the whole thing coming together. I also took on the role of Session Coordinator and had the additional responsibilities associated with that. And if that wasn't enough I moved yet again just prior to State Session.

I don't know how it all happened and I'm not going to question it, but as I finish writing this report and print it, I'm reminded that State Session isn't starting for another four days. I can't help but think what I forgot.

In conclusion there are some people that I would like to thank for assisting in the planning and execution of all that goes with State Session. My daughters Sarah and Emilie for helping with folding and stuffing the materials for the packets. State Master Chris Heath for being available when needed and for filling in for me at the last area meeting. State Ceres Kerriann Heath for taking charge of the banquet. The team that attended the walk through Chris, Arthur Mark, Lois, Kerriann and Sarah to make sure nothing was forgotten. And most of all I would like to personally thank each Pomona and Subordinate Secretary for the time they take in their busy lives performing the duties of this office.

Furthermore, they were informed that he would like to meet with their Grange before they start the process. The State Master planned to attend the

next meeting but was informed that they were cancelling it. Awaiting notification of their next meeting so he can talk with the members to discuss their options.

- Merrimack County Pomona ~ attended the last scheduled meeting of Merrimack County Pomona. At the meeting, the Pomona members of Sunapee Lake Grange decided that they would like to have their membership transferred to Suncook Valley Pomona Grange instead of Mascoma Valley Pomona Grange. The request was honored. Subsequently a letter was sent to the Secretary of Mascoma Valley Pomona Grange informing her that there would be no members coming to their Pomona Grange from Merrimack County Pomona Grange. She was also informed that no money would be coming to them due to no members being absorbed into their Pomona. Also, informed the Secretary and Treasurer of Merrimack County Pomona Grange of their duties once the quarterly report had been made to the State Grange. Informed them that 2/3rds of the remaining money was to be handed over to Suncook Valley Pomona Grange and 1/3<sup>rd</sup> was to be handed over to Pemigewasset Valley Pomona Grange.
- Upper Coos Pomona ~ The State Master has been working with the secretary to collect the dues from those members who wish to remain Pomona members for the rest of the year. He has informed all four Granges of this Pomona of what is happening and told them that any member who doesn't pay by June 30<sup>th</sup> will be dropped from the Pomona membership list. The secretary was instructed to transfer all exempt Golden Sheaf members to the new Pomona. Also instructed the secretary that once the quarterly report is completed and the check is cashed, he needs to close all bank accounts and send all monies to the secretary of Northern NH Pomona. Arrangements will be made to pick up all Grange property and move it to the State Grange Building.
- Hooksett Water Department ~ State Grange has been contacted by the Hooksett Water Department for authorization to dig in the back of the State Grange building. Due to short notice from the town, and no time to contact the Executive Committee the State Master authorized them to dig with the condition that fill in all holes/trenches that they create. Going forward there should be a process for authorizing this type of work at the State Grange Building in the future.

Some comments were made from the members during the presentation of the Master's report. It was suggested that we add to the guidelines the distribution of money when a Pomona is redistricted. Motion was made by Robert Haefner and seconded by Mark Collins to accept the Master's report. Vote was favorable.

#### Secretary Report:

- Reported that the following Granges are behind in reporting: Barnstead Community, Granite State, Londonderry, Park, and Pleasant Valley.
- Report to National has been sent
- State Grange Banquet: the cost of the banquet is \$33.86 per person with all tax and gratuity included. The secretary offered two suggestions with the cost. 1) Lower the price to \$30 to make it more affordable and hopefully increase attendance. 2) Raise the cost to \$35 so that the accounting is less confusing and the little that is gained will help

offset the expense to provide tickets to the National Representatives. After some discussion it was decided to charge \$35 for the banquet.

- The hotel can provide a cash bar outside the banquet room for those attending who wish to purchase wine, mixed drinks or soda. The cost of this would be \$100. After much discussion, a motion was made by Wilber Heath and seconded by Beth Merrill to not have the cash bar available but to ask the hotel for a beverage station in the banquet room. The vote was favorable. The secretary will contact the hotel about the beverage station.

A motion was made by Chris Heath and seconded by Tricia Taylor to accept the report. Vote was favorable.

#### Treasure's Report:

- Income Tax report has been sent
- \$752.76 was received from Somersworth Grange.
- Bill from the former secretary of Somersworth Grange for \$161.25
- Income and expense reports were distributed and reviewed.

Motion was made by Mark Collins and seconded by Wilber Heath to accept the Treasurer's report. Vote was favorable.

#### New Business:

- The State Secretary will look at the Concord and North Conway areas for the 2017 NH State Grange Session.
- Church lease: Motion was made by Wilber Heath and seconded by Tricia Taylor to renew the lease with the church for another year. Vote was favorable.
- Request from former Somersworth Grange Secretary for payment of a bill. Motion was made by Wilber Heath and seconded by Mark Collins to pay the bill. Vote was favorable.
- Watatic Grange needs help to reapply for nonprofit status. \$400 is needed to reinstate them. A motion was made by Chris Heath and seconded by Tricia Taylor to offer to loan the money to Watatic Grange to be repaid to the State Grange by January 1, 2018 if they accept the offer. Vote was favorable.
- Zumba Class: motion was made by Mark Collins and seconded by Robert Haefner to offer the use of the hall at \$300 a month for a 3 month trial. Vote was favorable. Wilber Heath will draft the lease.
- Discussed the changing of the locks on the exterior doors of the State Grange Building. Motion was made by Chris Heath and seconded by Mark Collins. Vote was favorable. The Secretary will work with Hannah West to set up the change. All keys will be printed do not duplicate and will be issued by the State Secretary. A log will be kept by the State Secretary as to who has keys.

With no further business to discuss a motion was made by Wilber Heath and seconded by Robert Haefner to adjourn. Vote was favorable.

Meeting called to order at 7:43 PM with Treasurer Daniel Bascom acting as Chairman for the evening.

The minutes of the June 23, 2016 meeting were reviewed and minor corrections were made. A motion was made Wilber Heath and seconded by Christopher Heath to accept the minutes as corrected. Vote was favorable.

Master's Report:

- Peterborough Grange: State Master Heath spoke with Attorney Don Whittum to inquire about the status of the court case with Peterborough Grange. He was informed that case is in the hands of the courts. Once the court has set a date, all parties will receive notification of the hearing. This could take a while as this is not a criminal case and those types of cases take precedence over civil cases. Attorney Whittum predicted that it might take as long as six months to get a date for the hearing. A freeze has been placed on the accounts held by Peterborough Grange back in March.
- Mt. Pistareen Grange and Halestown Grange: Letters have been drafted to both Granges informing them that their charters are being suspended because they are in violation of the National Grange By-laws Chapter 4, Article V, 4.5.1(D) A Grange refuses or is unable to hold meetings, as provided for in Article IX of these By-laws, which reads Article IX—MEETINGS 4.9.2 Subordinate Granges – Shall meet at least once each month, however, such granges may vote to hold additional meetings. Seven members is the least number with which a Subordinate Grange may be opened in due form, and shall constitute a quorum unless a greater number is provided in the By-laws of the State Grange having jurisdiction. In cases where a quorum is not present, the Master may adjourn the meeting from time to time until a quorum is present. Arthur Merrill is assisting in providing other requirements laid out in the National Grange Digest.
- Barnstead Grange: State Master Heath has been in communication with the Grange Master to get their dues and reports caught up. He has received two past reports via E-mail and they are submitting them to the State Secretary.

- Prentice Hill Grange: There has been no further communication from the Grange since their initial notification that they are considering closing their Grange. State Master Heath has tried several times to contact members of the Grange to find out when they might meet next with no success. The Master of Prentice Hill Grange will be contacted to find out when will be a good time for him and State Master Heath to discuss this.

Secretary's Report:

- The following Granges have not yet filed their June quarterly report with State Grange and currently are unable to vote at the upcoming Annual Session.

- Four Granges have reported Junior Members, Centennial 2, Chichester 1, Hudson 1, and Watatic 9.
- Assessment Bills: Bills should have been sent out in the spring but with the closures and consolidations of several Granges the since June 30, 2015 quarter some clarification was needed as to who would be paying for the members affected by the consolidations and closures.
- State Session 2016: plans are well underway for the upcoming State Session. Currently four resolutions have been received with the deadline coming soon for By-law changes. Session rules have been up dated and will be covered under new business.
- Memorial Service at State Session: The Secretary wanted clarification as to whose name should be on the Roll of Deceased Members for the Memorial Service. Currently only Past Masters, Spouses of a Past Master, Past or present pink sash holder who has been reported by June 30<sup>th</sup> of the current year are included. Some feel that if someone passes away prior to session they should be included. After some discussion, it was agreed that only those listed above that have been reported from July 1<sup>st</sup> of the previous year to June 30<sup>th</sup> of the current year be on the Roll at the Memorial Service. With the exception of the passing of an individual with strong State Grange recognition between June 30 and State Session.

- State Secretary reported he will be moving in late September so the office will be shut down for a few days but should not be a problem. The current computer is running slow and is not compatible with some of the new window products. He is requesting to be authorized to purchase a new computer.
- State By-laws: noticed that page 12 Article XIV, 2 need to change dues amount to \$7.75. This will be up dated after State Session following the voting of the resolutions presented.

#### Treasurer's Report:

- Income and Expense reports were presented. Currently there is a \$334 balance for uncollected Bonding Fees for 2015. The Fundraising Committee raised \$1250 for the 1/20 Club.
- Budget will be discussed under new business.

Motion was made by Wilber Heath and seconded by Mark Collins to accept the Master's, Secretary's and Treasurer's reports. The vote was favorable.

#### Old Business:

- Pomona Disbursements: Merrimack County Pomona was closed effective June 30, 2016. The Granges were redistricted to Pemigewasset Valley Pomona and Suncook Valley Pomona. The accounts for Merrimack County Pomona were closed and all monies (\$2106.19) was sent to the State Grange. The money will be distributed as follows: 2/3 for Suncook Valley Pomona and 1/3 for Pemigewasset Valley Pomona.
- Exterior locks at the State Grange building: The secretary will contact a local locksmith to have the locks changed and to also replace the handles.
- Zumba Class: The Secretary will call the instructor to see if she is still interested in using the building. If so Wilber Heath will draft the contract.

#### New Business:

- Peterborough Grange: discussed the tracking of expenses for purpose of reimbursement. Motion was made by Chris Heath and seconded by Bob Haefner to recover the expenses after the suit is settled. Vote was favorable.
- Motion made by Beth Merrill and seconded by Wilber Heath to absorb the \$80 assessment fees for those Granges closed since the June 30<sup>th</sup> 2015 quarter. Vote was favorable.
- A motion was made by Wilber Heath and seconded by Bob Haefner to approve the Session Rules and to have any \$5.00 cell phone noise fees donated to the NH Grange Foundation. Vote was favorable.
- E Post cards: some confusion on doing these with the IRS has been occurring. State Treasurer, Dan Bascom will be providing assistance to the Granges to have these done in a timely fashion. Any questions are to be referred to him.
- A resolution was presented "Beverages at State Grange Banquets". Motion was made by Mark Collins and seconded by Wilber Heath to accept the resolution. A motion was made by Mark Collins to amend the resolution by changing THE to A before NH State

Grange on line 2 and 6 of the last paragraph and adding “where alcohol may be served” at the end of the last line of the last paragraph. The amendment was voted favorably and the amended motion was voted favorably with one members in opposition.

- Proposed 2017 Income and Expense Budget was presented and discussed. The final version to present to the Delegates at State Session will be voted upon at the next meeting.
- A question was asked if the NH State Junior Grange have By-laws.

The next meeting will be on Sunday October 16, 2016 at the State Grange Building at 10 AM. The Secretary’s and Treasurer’s books will be audited.

With no further business to discuss a motion was made by Wilber Heath and seconded by Chris Heath to adjourn. Vote was favorable.

General Deputy Andrew Savage was escorted to the Masters station to present his annual report.

Worthy Master, Brothers, and Sisters

I have learned a lot this past year serving as general deputy and not all of it has been good. We have some real challenges ahead of us, and I ask all of you to do whatever you can to help us overcome them.

#### Subordinate Granges

One thing I have learned while interacting with the granges, either myself or through my team, is that there seem to be three types of granges. The first type is the grange that has a yearly planning meeting, and if they’re not contacted by their deputy, they will reach out to them to let them know when they are expected to visit their grange. The second are the granges that are able to find a mutually acceptable visitation date when contacted by their deputy. The third category belongs to granges that always seem to have a reason why they can’t give the deputy a date. Sometimes they promise to get back to you with one, but never do. You generally never see these members at state events either, which means they aren’t here to listen to this report. These granges are of great concern to me partly because they are not contributing to the grass roots nature of our organization, partly because we have no idea what great things they could be doing in their own communities that we might even be able to learn from, and partly because some of them are the ones who really need our help and guidance. It makes me wonder why they belong to a grange if they have no desire to be part of the grange.

Let's look at some of the percentages that I have extracted from the reports I have received. Roughly 15% of our granges never scheduled a time for their deputy to visit them in the spring. Given all the changes to the scoring this year, those granges are at a disadvantage in more ways than one.

Around 17% of the granges that were visited failed to provide their deputies with the proper secretary and treasurer records. Some of these were due to illness or accident, but almost half of our granges aren't keeping their records audited on a quarterly basis. The state master and state secretary recently toured the state in an attempt to help the subordinate granges understand what is required of their masters and secretaries. I hope these training sessions will result in improvements in the coming years.

Roughly 20% of our granges reported that they are not properly filing their 990N. This is a huge problem because it affects the non-profit status of our granges. Unless you want to start dealing with taxes, you need to file this every year. In the past, the state treasurer has been willing to assist granges with the filing of the 990N, so please contact him if you belong to one of these granges, or know someone who does.

On a positive note, our efforts to emphasize the opening and closing ritual of the grange seem to have had some success, as the number of granges not performing any type of opening ritual has dropped from close to 50% down to around 25%.

This year, we continued to challenge the granges to accomplish a goal that would require them to get outside of their comfort zone. The intent of the goal would be to increase either membership or recognition of the grange within the community. I am happy to report that half the reporting granges accepted and conquered their challenges, which is substantially better than the response we had the previous year. It seems that adding them to the scoring system worked the way I hoped.

On the subject of scoring, we did add some other new ways to get points this year. As a result of these changes, we have a new top grange for the first time in years. The top 3 scores from the reports that I have received are:

3<sup>rd</sup> place: Wingold grange

2<sup>nd</sup> place: a tie between the previous winner Wicwas Lake grange, and Baker's River grange

1<sup>st</sup> place: Blow-Me-Down grange

Congratulations to all of these granges for all the work and effort they have put into the organization over the past year.

#### Pomona Granges

We only have one deputy assigned to the Pomona granges, and as he requested permission to submit a report of his own, I saw no reason not to include it here.

Arthur Merrill, having visited every Pomona grange at least once this past year, sent me this report on Pomona Granges in New Hampshire.

The condition of the eight Pomona Granges in New Hampshire is at best mediocre.  
Not one Pomona conferred the fifth degree this year.  
We lost three Pomona Granges since the last State Grange session.

Carroll County Pomona #8 consolidated with Eastern NH Pomona in November 2015.  
On June 30, 2016 Upper Coos Pomona #14 consolidated with Northern NH Pomona #5.  
Also on that date Merrimack County Pomona #3 closed and the subordinate Granges were redistricted to either Suncook Valley Pomona #12, or to Pemigewasset Valley Pomona #18.

Some of the Pomona Granges are struggling to have a quorum present at their meetings.

Most of the Pomona Granges are not much more than a "social" meeting, a chance to get together with other members and discuss what each of the local Granges are doing.

What should we do to fix these and other problems that face Pomona Granges in NH?  
Do we redistrict more, having only 3 or 4 Pomona's?

Do we only have One Pomona in the state meeting quarterly throughout the state, possibly conferring the fifth degree at State Grange session?

Do we eliminate Pomona Grange altogether in NH? At least two states are discussing that at their session this year.

Pomona Grange, at one time served a very useful purpose in our order. I believe, however, that it's time has passed.

The Steward announced that Lorraine Merrill, Commissioner of Agriculture for the State of New Hampshire is our guest and waiting. Master Heath had her escorted to his station to address the members.

The Grange was at recess for The New Hampshire Grange Foundation Annual Meeting. During the meeting Robert Haefner, President of the NH Grange Foundation presented his annual report.

Richard Patten, State Historian presented his annual report.

Worthy State Master, National Representatives, Delegates, Patrons All!

Once again the NH State Grange has returned to the City of Lebanon. I found in 1957, the 84<sup>th</sup> annual session was held in the Lebanon Lower Town Hall. George Clement was serving as State Master and Carl S. Adams was serving State Assistant Steward. It is noted on Friday, the Youth were invited to conduct the session. Some of the officers you might recognize were: Master Gordon Bemis, Sugar River Grange; David Bradley of West Thornton, serving as 'Assistant Steward, Philip Shattuck of Granite Grange serving as Secretary, Phyllis Taylor from Blazing Star Grange and Raymond Burton from Pine Grove Grange were members of the Executive Committee. The State Master in his address hoped that a Pomona Agriculture Committee would sponsor a Dairy Queen Contest. It was announced later the State Home Economics Committee would be sponsoring it on a Pomona level. The Secretary reported the Pomona membership of 11, 724 in 27 units; the Subordinate Grange, a membership of 26,236 members in 266 units; and 1,632 juvenile members in 48 juvenile granges. The Degree of Flora was conferred on 157 candidates.

The NH State Grange returned to Lebanon in 1983 for its 110<sup>th</sup> annual session being held at the Elks Club. The membership in 1983 was 4,413 in the 25 Pomona Granges. The 151 Subordinate Granges reported a membership of 9,654 members. The Junior Grange membership was 302 boys and girls in 20 Junior Granges. The Sixth Degree was conferred on 74 candidates in the Lebanon City Hall Auditorium.

It has been nine years since we last came to this hotel in West Lebanon to hold our annual session at the Fireside Inn and Suites. Even though, it has been nine years, much has changed in Lebanon and in our great Organization. This past year has been a very busy one as your State Historian. Many times I feel like a detective doing research and trying to find answers to questions people are asking. I have been busy this year trying find members whose names have changed, looking for information as to where the Grange last met, looking for former members, towns who are having special anniversaries and would like to include the Grange located in that town. The biggest question I get asked is "why did the Grange close"? Where is the property or records?

I have been working with the town of Atkinson who is planning a 250<sup>th</sup> anniversary in 2017 and would like to include the Atkinson Grange in one of their programs. The people of Amherst are also planning a celebration and are trying to find out more about Skowhegan Grange. I have gone back through journals and rosters and offered information as to what I could find. I had a request for information about the Grange being involved in the Weeks Act in 1912. I contacted my friends at Legislative Services and they found the information that they were looking for. It was determined that it was more involving the Federal Government.

I continued my project of trying to return Secretary minute books to the local historical societies or libraries in the town where this Grange was located. I returned the Secretary minute books to Golden Grange of Lisbon, Lyman Grange, Lyme Grange, and Daniel Webster Grange of Webster. After several phone calls and three visits, I now have the books for Moultonborough Grange. I also have the Secretary Minute Books for Salem Grange. The two ladies who came to my home from the Salem Historical Society but said they didn't have room for all the Secretary minute books. The remaining books have been moved to the State Grange Building in Hooksett.

I am hoping that two or three guys would be willing to go to the State Grange Hall and bring up the boxes in the basement so we can find out what books are there. I have requests for Westboro of West Lebanon, Blue Mountain Grange and Mt Cube Grange. I have also been doing research on Wyoming Grange of South Weare. They are planning a town celebration next year and they are trying to find why the name Wyoming was chosen. I spent many hours looking for information regarding the original Grange in Orford. The person looking for this information was none other than my 10<sup>th</sup> grade teacher, whom I hadn't seen since 1967. His parents were very active members of Wentworth Grange and then Mount Cube. I went back to 1877 and found the information about Orford Grange. This Grange only lasted for about five years. I have also had telephone calls about Loudon Surprise Grange, Highland Lake Grange, Parker Mountain Grange and Province Road Grange.

I truly enjoy trying to help people who formerly held membership. One example was a lady who called me to find out when she joined. After much research and talking with our State Secretary and State Master, I finally found it and confirmed it was her.

This year our Heavenly Father continued to add more members to his roll. What is difficult for me is that some of these members were so active and now are taking their next degree. Most of these have taken their degrees and renewed friendships in that Great Grange above. I am not sure if this next section of my report is interesting to some or not, but I feel that I would like pay homage to them and let them know they were much appreciated and missed. These are just a fraction of those who were called to the Great Grange:

Russell & Marjorie Brooks from Aurora Grange of Pittsburg were called to the Great Grange. They were the major cogs of the Grange in Pittsburg. Russell was a past Master of Aurora Grange and Upper Coos Pomona with Marjorie being very active in the Grange along with being involved in other town organizations.

Mary Ham of Rochester Grange was a very active member of the Grange. I first met Mary when I was a Junior Deputy and assigned to Banner Junior Grange. Mary assisted her sister Grace Leone, who was Matron/Leader for Banner Junior Grange for many years. Mary's children were members of the Junior Grange. Her son Wesley played the piano very well. He gave the Junior Grange something that many Junior Granges let alone Subordinate Granges wished they had.

Glen Creighton who belonged to Daniel Webster Grange and Pineconia Junior Grange was a very talented young man. When he was a junior grange member, he would play the guitar and sing. Many times he would accompany his parents when they sang at meetings. He entered in several State Youth Talent Competitions. It was sad to have him leave this world so young but I am sure he is with his mother, late Joyce Creighton who had passed away a few years ago.

Tuftenborough Grange lost two members this year who were very active in past years. Dorothy Glidden, who transferred from Lake Shore Grange, had been active on the State Membership Committee along with filling offices in both Granges. Curtis Pike served as a Subordinate Deputy and knew his deputy work well. Curt would travel through Carroll County and Belknap County to do instructions and inspections.

Wicwas Lake Grange of Meredith Center also felt the loss of Irene Greenleaf who passed away this year. Irene was a very active member of Wicwas Lake even in the lean years. She continued in her pursuit in Wicwas Lake Grange knowing that someday this Grange would make a comeback. Irene would travel with David Boynton to meetings along with Pauline Champny.

Concord Grange had a couple of members they hadn't heard from in years. Chesley Hall was a member of Loudon Surprise Grange and later Bow Grange. When Bow Grange merged with Pineconia, he came in with his mother Martha Hall, a past Juvenile Deputy. Our Secretary asked me if I could assist in trying to find him. There were no family members still living in the Concord area and the last address we had was Florida. After several telephone calls including a local funeral home, he was located. Unfortunately he had passed away 10 years ago. Someone had been opening his mail, but never returned it. The same situation was with William Pluff Jr. He along with his mother and father were members of Pineconia Grange, and then they transferred to New Union Grange of Hopkinton, and then to Contoocook Grange. William Pluff Jr was past Master of Pineconia Juvenile Grange and Pineconia Grange along with New Union Grange. After several calls to his former residences in Florida, it was discovered he had passed away two years ago.

Clayton Tuck supported his wife Alice in all her Grange work as well as being active in Rochester Grange. Clayton was a Past Master of Rochester Grange and was always ready to help whenever needed. They also had their sad times, losing a son in the military. They knew family came first and spent as much time as they could. Clayton's health took a turn for the worse and spent his last months in Epsom Medical Center. Alice would visit him almost every day until he was called to the Great Grange above where he would see his son again.

The Rev. Gregory Derick was a member of Grafton Star Grange. Although I didn't know Rev. Derick, I knew he came from a very active Grange family. A month later, his mother Velma Dimick passed away. She was a member for over 75 years and a member of Morning Star Grange of Lyme.

Velma Pope served the NH State Grange as Pianist. She had a gift that many Granges would love to have. She could play the piano like none other. She played the piano for her local Grange. She also served as Master for Purling Beck Grange of East Washington. I am sure she is joining the other past State Pianists in the Great Grange above and continues to make the beautiful and wonderful music.

Aurora Grange lost two members already this year but they lost a valued member in Bernice Fish. Bernice Fish was the backbone of Aurora Grange. She served as Master of Aurora Grange and Upper Coos Pomona Grange. She was appointed a Juvenile Deputy in the northern part of our state. She spent many hours with the boys and girls in the Juvenile Grange. I was much honored to present her with a Lifetime Achievement Award. However due to an ankle injury, she was not able to attend last year's session to receive this award. I asked one of my committee members to present this award to her.

Stratford Grange lost two very valuable members, Robert and Gladys Lovering, who passed away within months of each other. Robert served as Master and worked very hard to keep his small Grange active. Their daughter, Cindy Aldrich, served as State Lady Assistant Steward several years ago.

I was very surprised when I learned Ernest Davis, former State Subordinate Deputy and Past Master of Moultonborough Grange had passed away. I was having a difficult time trying to locate the Moultonborough Grange and Carroll County Pomona Grange books. I made many telephone calls and was told he was in Laconia living for the winter at a nursing home, then I was told he was Selectman and in the office every day. I called and he hadn't been selectman for ten years. Ernest was a quiet Grange member doing his Grange work and making his Grange visits. He was a vital member of Moultonborough Grange.

Marion Stone, who celebrated her 100 birthday last year left our Earthly Grange to join her late husband Jessie Stone in the Great Grange Above. Marion served her Grange well as Master in Park Grange, as Past Master of Mascoma Valley Pomona Grange and as State Education Committee Chairman.

Ruth Gray served as Junior Deputy, State Pomona, a member of the State Executive Committee, Director for State Home Economics Committee, Chairman for the Grange Family Weekend, and State Membership Director. She and her late husband Stanley moved to Florida and she became active there eventually becoming State Master of Florida. Ruth held membership and was a Past Master of Lebanon Grange. She served her Grange well. She served as Matron/Leader for Lebanon Juvenile Grange. She was all set to attend this year's session in West Lebanon. Her passing was sudden and a loss that will be felt in this area of the state.

The final member I will talk about is the passing of Past State Master Paul Davis Sr. Paul was a dedicated, hardworking Granger. He joined Ossipee Mountain Grange in 1944, eventually moving to Lancaster and become Master of Mount Prospect Grange. He and his wife Rhoda and their family worked very hard through the years. He served as Subordinate Deputy for many years. Then he and Rhoda moved to Loudon NH and he started his business. They joined Pembroke Grange and Suncook Valley Pomona. In addition they joined as affiliate members of Hooksett Grange to help them in membership. They would travel to so many Granges in the State. He became elected to a member of the State Executive Committee, then to State Steward, State Overseer, and State Master. He and Rhoda represented the state very well at National Grange and became members of the Assembly of Demeter.

One of his favorite pastimes was playing cards. He and Rhoda would spend many hours' playing cards whether it was cribbage or just one of many card games. At Family Weekend, you would find Paul and Marilyn Machia playing cards for hours. He was a dedicated man who will be missed by many. He and Rhoda traveled around the state taking photographs of almost every Grange Hall in the state or where Granges met. They compiled a book which I have the here at this session and I hope you look at it. He worked many hours at the State Grange Building in Hooksett whether it was mowing the grass, planting flowers, or cleaning inside. When a Grange would call him to install their officers, he would always say yes. Now, he didn't have a regular installation team, but many times, Rodney & Shelley Huntoon, Debbie and I, Celia Andrews,

and others would be more than happy to help him. He knew his installation charges as well as his Grange work like none other. One of his funny moments was when I was State Lecturer and he was a good sport by being a Rockette in the New Hampshire program. Yes he joined myself, Bob Trombi, Arthur Merrill, Jerry Leclerc, Jim Tetreault, and few others dancing to New York, New York number. If anyone deserved the Well Done Good and Faithful Servant, it was Paul Davis Sr.

I have had comments said to me this year that I live in the past too much especially when I talk about the Grange. I have learned so much about this organization. I have made many friends in the Grange, and it is sad when we lose our members who have done so much for this organization. I enjoy talking about what the Grange did in the past reminding people how active we were and how much power we had in the Legislature. There is no reason why we can't be just as active again.

Worthy Master, I would like to close by saying I very much enjoy being State Historian and someday I hope to get a book I have been writing published. I have no problem researching information for people who are trying to get to know the Grange, who we were, why we were organized, what purpose do we serve and learn more about this great organization.

Thank you to my wife for typing and shaping this report and thank you to you State Master Chris Heath for having faith in me to be the best Historian I can be. I just love this position and I continue to learn more and more about this great organization.

The acting Steward, Kathy Yardley announced that Beth Merrill, Youth Director and Joann Brandt, Junior Director were ready to present their annual reports. The Assistants were instructed to present them to the Masters station.

Worthy Master, Distinguished Guests, Delegates, and Patrons All:

It has been a privilege to serve as your Youth Director the last two years. I appreciate the efforts of my committee Allissa Estes, Emilie Leclerc, Adam Paquin Varnum, and Sarah Leclerc as they pitched in to help get things planned and organized throughout the year.

The new Grange year started with the **National Grange convention** in Lincoln, Nebraska shortly after the conclusion of our State Session. I attended a meeting of State Youth Directors, Adam Paquin Varnum, received a blue ribbon for his entry in the Folding Display Contest, and Kathy Yardley performed her regional best of show Sign-A-Song entry during the Evening of Excellence.

**You're Fired!** Seven members attended this fundraiser in Concord on the day of Deputy School last December. Part of the fees each participant paid to select and paint a ceramic item was donated to our organization. Not a big money-maker for us, but it was **fun** and we hope to do this again in the coming year.

In January I met with the other Youth Directors of the northeast region at the regional **Leaders' Conference** in Massachusetts to discuss our mutual programs and to make plans for the upcoming summer regional Youth conference. Later that month, youth members and supporters gathered in Antrim at the home of Arthur and Beth Merrill for **Moon Stomp**. After Spring Fling, the youth and the young at heart headed off to enjoy our second annual **Fun@Funspot** to unwind and have some fun. Everyone split up into two groups, and worked together to complete a scavenger hunt. Once completed, everyone came back together for delicious cupcakes and ice cream and announcement of the winning team, whose members got 100 tokens to split among each other. After the team activities were over, everyone continued to enjoy the facility at their leisure.

Youth member, Adam Terrell, from Walpole Grange entered the Variety Act category of the **Lecturer's Talent Contest** with an Abenakis fable about how we came to have maple syrup. Adam was awarded the Best of Show and will be presenting his talent at National Grange's Evening of Excellence next month. Brother Terrell will be busy representing NH while he's there, as he's been selected to serve on the Executive Committee for the Youth Opening, and he will also help Pennsylvania field a team to compete in the Parliamentary Procedure Contest. Adam is a bright spot on the horizon for our NH youth program.

Due to many schedule conflicts, there were no youth officers in attendance at the Danbury **Degree Day**, but there was one youth member, Anna Murphy of Antrim Grange, who attended as a candidate. Thank you to all the young-at-hearts who filled the chairs for the Second Degree that day

**June Youth Rally** was held at Copper Cannon Camp in Franconia, NH June 3-5. Having received registrations for only nine overnight campers, I seriously considered cancelling the event. However, two of those registered were new, teenage members who I felt deserved to experience the same overnight Youth Rally event many of us have enjoyed in the past. I am so glad we continued on with our plans, as it was a great weekend, intimate and relaxed, with some great learning opportunities sprinkled in. Arthur Merrill presented the Friday night workshop on our Seven Founders, which lead into our Saturday morning activity of clearing and landscaping at the John Thompson roadside memorial in Littleton. We made Father's Day cards for the Lecturer's contest, enjoyed a terrific workshop on identifying various personalities by Kathy Yardley, listened to Adam Terrell's public speaking entry, played Grange Baseball, and tried our hand at some contra dance moves. There was a Sunday inspiration service led by Mary West, a brainstorming session for ideas for the youth department's fair exhibit, a review of the weekend's activities and we headed for home just as the heavens started to let loose! Otherwise, we enjoyed lovely weather and equally lovely accommodations.

Youth members Emilie Leclerc (Hudson Grange) and Adam Terrell (Walpole Grange) accompanied me to the **Northeast Youth Conference** in Cobleskill, NY in July. We participated in get-acquainted games, workshops, and a tour of Secret Caverns. I was extremely proud of Emilie and Adam who each were participants in the Grange Jeopardy competition competing elbow to elbow with much more seasoned young adult members who were extremely fast on the buzzer. While they did not qualify for the regional team that competes at national session, they did show a basic knowledge of Grange trivia, and more importantly, were great examples to other youth in the audience to be future contestants. Workshops included a collection of turtles and snakes by a NY youth member who is an avid collector, and the High Priest of Demeter, Bruce Croucher, a NY Granger, spoke about the duties of his position and brought along the original book that has the secret work written out and illustrated. We so appreciate the support of our State Master, Chris Heath, who attended much of the conference and he, Kathy Yardley, and I cobbled together an entry just prior to the conference to compete in the Sign-a-Song contest. There were no other entries in the group category, so we received first place by default. Many excellent public speaking entries were presented and our own Adam Terrell impressed the judges enough to receive first place in his age category. On Saturday evening we learned some fun folk dances. Sunday morning wrapped up the weekend conference with a church service followed by the traditional Drill Team competition with the Massachusetts team emerging as victors. Chris and I were asked to judge the competition and were busy in another room tallying scores, while the presentation of the Spirit Stick was made to the NH delegation. It was quite a surprise that our small delegation would be honored this way, but Adam and Emilie were excellent ambassadors for our state and I am so proud and happy for them to have received this honor! On a side note, thank you, Rick Bailey for adding the NH name and color to the stick, which is on display at the youth table here at this session.

A **Youth Committee exhibit**, "Fun For the Whole Herd", was entered in four fairs this summer and fall, and received two red ribbons and two blue ribbons. We also received a trophy for best Grange exhibit at Hillsborough County Fair.

There were no entries this year in the **Photo Scavenger Hunt**. This contest has been removed from our youth program for 2017.

In the past year we were raising money for the **2016 DC National Session Travel Fund**. We thought we might fill a coach bus to get folks transported to the convention next month. There was not enough interest for that, and after a couple more downsizes to our plans, we are now down to a minivan with four people heading south in November. The leftover money that was raised for this travel fund will be turned over to the new director and designated for the Jodi Bailey Youth Fund so that more youth can receive assistance to attend these very important conferences.

Last year we could assemble only a partial slate of youth officers for this Session, all of whom were asked to sign a commitment form to perform the duties of their office at the few events that require the presence of our youth officers. The State Master and I had hoped we could instill a sense of responsibility and importance to those who seem to value the privilege of performing at State Grange, without accepting the long term requirements of the position. In a couple of instances, my request for this commitment was met with resistance, and in a couple of other instances, those commitments were not fulfilled. This year, with no entries in the Youth Officer Contest, and no election of youth officers held, due to the low attendance at June Youth Rally, there was not a **Youth Officers** opening at this year's State Session. This is the first time in my years as a Grange member it has been omitted. It is a sad day for our State Grange. Even more upsetting is that no member has spoken to me in protest of this decision. Is there no one outraged?

I am not sure what the prospects are to have the youth opening restored to our program, or if indeed, the delegates have missed seeing it here, or if the youth really want to be here. I hope this is a one-time occurrence and that the youth have received notice that this is an honor that must be earned, not assumed.

I KNOW there are youth members out there in your Granges that we never see or hear from at our state events and contests. Who is mentoring these young people and providing them with opportunities to grow in the Grange? When was the last time your Grange made a serious effort to put on a Youth Night program? What activities/projects could your Grange do if you had assistance from young adults? Can you offer them a ride to a state youth function?

Often I hear this comment, "Young people are not interested in the Grange". That is a blanket statement and is just not true. It is your duty to your organization, local, state and national, to seek out those young people, show them some examples of how your Grange work can appeal to their interests, and ask them to join. Then the REAL work begins at your meetings, because having these new members will probably require your Grange to make some sacrifices in order to make them feel welcome and give them a sense of ownership.

Look around this room. Twenty to 30 years ago, half of these State Officers were your youth officers. That was an investment that has benefited our state organization exponentially. But where will we find the leaders who will carry on after us, not thirty, not twenty, but what about just TEN years from now? When you look around this room do you see enough members to fill all the leadership roles that we'll require to maintain a strong state Grange? I hope we can all get behind our new youth director and work together to rebuild this vital program. It is essential to

the existence of the Grange.

I received a total of 4 Pomona reports and 14 Subordinate **reports** this year. That's only one more report than last year. Some Granges submit reports and claim points only for reporting youth activities at each meeting, stating that they have no youth. While I am happy to receive the report, I am frustrated by the inactivity of such Granges. When you take the time to read our program booklet, you will notice that roughly two thirds of the activities and contests in our state youth program have no age limitation.

The last engraved plates on the **High Youth Score Subordinate and Pomona plaques** were completed last year, so they will be retired for permanent display at the State Grange Building. I defer to the next Youth Director to determine if it is worthwhile for this type of award to continue, where there are fewer and fewer Granges owning halls and therefore having appropriate space to exhibit them. So this year, in lieu of an engraved plaque I have framed certificates for the top Pomona Grange Youth Score going to Hillsborough County Pomona with a score of 440 points. The top youth score for a Subordinate Grange goes to Walpole Grange with a score of 430 points.

I cannot end any report without thanking my husband, Arthur, to whom I owe so much for all his support. He is truly a great **Youth Booster** to me and any youth or young adult member who asks for his help. Too bad for him that, as Youth Director, I don't feel that it's appropriate to award my own spouse for an award such as this. But there is someone who is greatly deserving of recognition - for always being on hand to support, mentor, and encourage the youth members at almost every event we held this year. We were proud of our tiny NH delegation to the regional youth conference, and our **State Master, Chris Heath**, was the only State Master that attended the full weekend at the Northeast Youth Conference. He is often a willing participant in our activities, never ceases to be a mentor and sometimes travels great distances for our department, when I know, sometimes there were really pressing matters he could have been attending at home.

I think that about closes the book on the 2016 youth activities of the NH State Grange. In closing, I remind you that the first three letters in the word "youth" spell YOU. That's Y-O-U, you! Regardless of the average age of the members in each of our Granges, the youth program relies on all of our members to support and participate in the youth activities. Without our older members, there is little leadership to train the youth to continue in our footsteps. Without our younger members, our Granges grow weak and stagnant due to lack of enthusiasm and innovation needed to carry us forward. Once we learn to balance our Granges with the strengths of every age group, we will be close in our pursuit of achieving the perfect Grange.

I am so pleased to have a representative with us from Upper Valley Haven, a shelter just across the border from West Lebanon to accept the first batch of sacks for use at this homeless shelter for the Upper Valley area of NH.

In closing, I want to thank my committee for all of their help, support and ideas. We work well together and I thank you. Committee members are Cam Twiss, Ann Leger, Virginia Clark, Mary West, Deb Stone, Linda Phelps, Alice Tuck and Katherine Umberhind. Most of all, thank you to my husband Dick. He hears me out, loud and clear most of the time and even though I bounce ideas off him I usually have already made my decision. He is patient and knows me by now – after 32 years. And a thank you to my sister Elaine who always helps with putting packets together and all the stuff that needs to happen to get ready for this convention.

It is a pleasure to present the annual report for Community Service. Once again, it has been a very busy and interesting year in community service. I am very proud of the accomplishments of the Granges in the state. I am so pleased that Granges on the whole, have continued projects they have been doing but attempting to do new projects. I am also pleased two organizations can work together because the project proved bigger than one group could handle. I feel that it should not be embarrassing to reach out for assistance from another organization.

Granges throughout the state have sponsored Halloween events, Christmas gatherings with Santa and gifts for everyone, Valentine parties, Easter Egg Hunts, sponsored Memorial Day programs, Fourth of July, Old Home Day parades, country fairs, Back to School projects, National elections, and it's time to start a new year.

The Santa Remembers Teens at Christmas was successful again. I know the Grange is a very dedicated group of men and women who care about this great organization the year before when we started this project to we collected over \$900 hundred dollars in gift cards. This past session we only collected \$500 hundred dollars. This was very disappointing; however much to my surprise I had two members hand me two checks to go and buy \$450 dollars' worth of gift cards.

The Friends for Forgotten Children and Operation Santa Claus were thrilled as you know someone broke in to their headquarters and stole hundreds of dollars of toys etc. Your generosity has helped so much to make Christmas a happy one for all ages.

Deb and I filled 14 Santa Stockings with candy, cookies, note pads, gift certificates, and few other items and took them to Liberty House. They were very happy when we arrived. They were very happy to think the Grange cared enough to send these cards and check in on them.

The non-member judges who judged the Community Service books had a tough time again. They took three days to read each one and discuss among themselves the pros and cons of each one. They couldn't believe how much work was done by the Granges in their communities and neighboring towns in some cases. The results are as follows:

First place: Wicwas Lake Grange # 292 of Meredith Center. This Grange did many special projects for the town such as a Haunted House with everything you can imagine. I am sure those who went enjoyed it tremendously. They gave the town's children a visit with Santa Claus and gifts, candy, and food. It was a wonderful project. They have a member who is a State Senator and she ran for Governor and didn't win in the primary but she still found time to enter in the baking contest. The Grange is non-partisan but she answered many questions about the state government.

Second place: Hudson Grange #11

Third Place; Concord Grange #322  
Fourth Place: Watatic Grange #36  
Fifth Place: Joe English Grange #53  
Sixth Place: Blow- Me - Down Grange #234  
Seventh Place: Mohawk Grange of East Colebrook #217

All of these Granges did an enormous amount of community service projects. Whether it was presenting scholarships, sponsoring parades, celebrating special holidays or traditions in their community, people of all ages came and enjoyed everything the Granges did. In many cases, if it wasn't for the Grange, a long time tradition or holiday event would have been cancelled. The Granges presented dictionaries to many third grade students in public schools, charter schools, or private schools. In some cases, the Grange worked with another business or organization to provide the dictionaries to the students. In most cases, the schools wanted the dictionary program to continue. I was pleased to see how many schools received dictionaries as a result of the dictionary program.

I appreciated the Granges, who honored citizens in their community. Recognition is very important no matter what community position or role they fill. It is sad that in every town there are people who served their country and yet no suggestions were submitted to honor. The Grange previously honored someone from the Postal Service in response to the Grange's strong connection and support for the start of RFD in New Hampshire. Next year, we are going to try a First Responder Award. This could be presented to rescue personnel, doctor, a nurse, a neighbor, a teacher. When there is an emergency, many times while you are waiting for help, someone will stop to see if you need help. They may render important service. This is a great way to thank them and recognize their efforts.

I know there are many people out there who should be recognized. Again, I am more than happy to assist you with this program.

I enjoyed reading what some of our smaller Granges did this year. Mohawk Grange of East Colebrook and Aurora Grange of Pittsburg are two Granges who do a lot for their communities. Aurora Grange made the news on WMUR TV 9 as they needed a new home for their food pantry. I have not heard if they found a new place, but they were looking for a new home. Watatic Grange is another small Grange but they accomplished so much. They had youth, junior members, and the adults all working together to make their projects successful. Claremont

Grange, small in membership, made Christmas very special for some special people. The Community needs the Grange and the Grange needs the Community.

Tonight, I will have the honor of presenting some very special awards to some very special people. Some of the people being honored tonight are volunteers who give their time to give service to the fire department. There are others who help educate our children and keep them safe all day long. We need to be vigilant as to what the Grange can do to prevent bullying. There are people who bully not only children but senior citizens as well. One of my goals this year is to contact a local nursing home, speak with someone in charge and see if there is someone who would appreciate cards on special days. There are many days in which residents will sit in their doorway and struggle to find a reason to smile. Can you imagine the smile on their faces when the postal service delivers mail to a resident?

I am also hoping the Pomona Granges will organize some kind of celebration to honor the NH State Police on their 80<sup>th</sup> anniversary. If you have a State Police Troop Headquarters in your Pomona, please contact them and see what you can do. You can also do something to show the local police or Sheriff Department that the Grange and community do appreciate them.

I would like to thank the Future Farmers of America who accepted my challenge last year to work on a joint project. I chose The Silent Warriors who work with the homeless in Enfield and Lebanon. The FFA collected several big boxes of food and toiletry items. I hope we can do this again next year or possibly another State Grange Committee.

I am so thrilled to report Grange members in the Granite State contributed over 14,927 hours. This does not include Granges who reported a question mark, wrote didn't know, or many hours. Many times, people don't want to be committed or have time to volunteer. They are working two jobs, transporting children to school events, sporting events, or just plain want to sit home and watch a TV show. Thank you to everyone who volunteered. Believe me your efforts are truly appreciated.

As I close this report, I would like to thank my wife Deb for her patience and assistance; a huge thank you to the members of my committee: Kevin Belval, Frances Everard, Haven Haynes Jr, Sherrill Bokousky, Doris Mitton, Brian Rossiter, Roy Stone, Erick Todd, and Brian Phelps. I would like to thank Donald Ross, Norman Brandt, and Brian Rossiter for their support and willing to lend an ear. Thank you to my sister in law Elaine Dame for helping Deb put the programs together. A huge thank you to my newspaper contacts who have published the articles that I sent to them.

I would like to wish everyone here a very Happy Thanksgiving and as you sit around the table, be sure to thank our Lord for his blessings and allowing us to do the best we can for each other and our communities. I also want to wish you a very Merry Christmas and Happy New Grange Year and a successful and prosperous 2017.

WHEREAS, Article XII, Section 1, Division 11 of the New Hampshire State Grange by-laws reads "NH State Grange policy shall permit the use of alcoholic beverages in fundraisers, in demonstrations or as gifts. Such containers shall remain sealed at such Grange meeting or activity. (10/30/2010)" and,

WHEREAS, the New Hampshire State Grange has recognized outstanding citizens at their annual State Grange banquet for many years and,

WHEREAS, these guests are not members of the Grange and are not required to abide by the rules and regulations of the Order and,

WHEREAS, the New Hampshire State Grange is not officially in session or in an official meeting during the banquet honoring these guests and,

WHEREAS, the guests to this banquet may prefer to be able to purchase beverages that are not typically supplied during the meal and,

WHEREAS, these guests consume beverages that are both alcoholic and non-alcoholic in nature and,

WHEREAS, these beverages that our guests like to consume are not made available unless contracted by the New Hampshire State Grange when making plans for the banquet and,

WHEREAS, having these beverages available during the banquet could possibly lower the cost of the meal, depending on the property, if it is contracted

THEREFORE BE IT RESLOVED, that the New Hampshire State Grange change Article XII, Section 1 Division 11 by adding the words "with the exception of a NH State Grange Banquet where alcohol may be served" after "Such containers shall remain sealed at such Grange meeting or activity." so that it reads "NH State Grange policy shall permit the use of alcoholic beverages in fundraisers, in demonstrations or as gifts. Such containers shall remain sealed at such Grange

meeting or activity, with the exception of a NH State Grange banquet where alcohol may be served.”

*This came from the executive committee, where the vote was unanimous in favor (State secretary change.. the vote with the executive committee was not unanimous) The committee discussed the proposal, and thought that, if the presence of alcohol was limited only to the annual meeting banquet, and every effort taken to be sure that children are not present at the time, it would a good idea. Many facilities and hotels will give discount on price of food if they will be making money on a cash bar. Therefore people who think the price of the banquet is too high should be in favor of this resolution. In addition, guests, award recipients and others who come to the banquet are expecting to have wine with dinner.*

THEREFORE BE IT RESOLVED, that Article 10.2.1 be amended by adding “only those members physically present at the meeting be allowed to vote.”

*Conference calls are prohibited. A legal meeting, according to the bylaws, needs 7 members present. Claremont agreed. This should not be changed.*

*Subject: Election of Officers at National Grange*

WHEREAS, the election of officer’s process is defined in National Grange Digest of Laws 10.4.1 as “ELECTIONS – 10.4.1 Nominating speeches shall not be allowed in any of the Granges in the various divisions of the order (Junior, Subordinate, State or National) at the time

of the election of officers; but in the election of officers, a member may present the name of another member as a candidate for a Grange office provided this rule has been adopted by the Grange having jurisdiction. A motion to close nominations is never in order and members may vote for a member whether the member's name has been placed in nomination or not." and,

WHEREAS, the original resolution submitted by Brother Aiken in 1873 was clearly started by saying "Resolved, That the election of officers at this session of the National Grange a majority of all votes cast shall be required to secure an election." and,

WHEREAS, Brother Aiken also stated in the resolution "Resolved, that in said elections there shall be no nominations, each member being allowed to vote for the brother of his own selection." Which is in violation of the above mentioned National Grange Digest of Laws 10.4.1 and,

WHEREAS, in all divisions of the order, except the National Grange, this process is followed by the numerous Granges across the country and have for as long as the organization has been in existence and,

WHEREAS, the delegates at National Session could spend valuable time doing other important requirements assigned to them instead of guessing who they should suggest as the officers of the National Grange and,

WHEREAS, the election of Officers at National Session is traditionally conducted by secret ballot and counted by the Assistants and the Steward and,

WHEREAS, sometimes the people who are elected to these positions are non-delegates and this directly affects the expenses paid by National Grange which in turn comes from Granges across the country and,

WHEREAS, the money spent to send non-delegates to National Session is money that could be better spent doing more programming, providing more member's benefits and other important grange work
